

EXECUTIVE ORDER NO. 11-84

FINANCIAL INTEREST STATEMENT

All citizens have a right to expect integrity in government. Therefore, all public officials must recognize that their duty to the City and its people cannot conflict with, or be compromised by, any other financial interests they may have. Accordingly, I hereby order that Cabinet members and their deputies, Commissioners and their deputies, members of the Mayor's Office and all members of Boards and Commissions, paid or unpaid, publicly to report the following information for themselves and their immediate families:

1. All sources of income in the form of salary, wages, fees and other compensation for services.

2. All sources of income from ownership interests in property or in any business, partnership or other entity, provided that the aggregate amount of income from any such interest equals or exceeds five hundred dollars for the reporting period.

3. All gains which equal or exceed five hundred dollars and five percent of the purchase price on the sale or transfer of property or investments, other than a personal residence.

4. All gifts and honoraria valued in the aggregate at one hundred dollars or more, including any transactions where the reporting party received value in excess of the value of their payment or property at the time of the transaction. Gifts between certain relatives need not be reported.

5. A description of any office or directorship in any profit or not for profit entity or association.

Public officers subject to this Executive Order shall certify that all information contained in the Financial Interest Statement is true and correct and that no financial interest held by the public officer or his or her immediate family has been the subject of any decision made by the public officer in his or her official capacity.

Filing of the Financial Interest Statement shall be made on May 1 in each year and shall cover the preceding calendar year beginning with the first year of my administration, 1984. The City Solicitor will prepare a list of persons subject to this order and circulate the disclosure form appended to this Order for making the required disclosures. Completed forms should be filed with Margaret Wilson, Department of Records, Room 164, City Hall, Philadelphia, Pennsylvania 19107.

A willful failure to comply with the requirements of this Executive Order shall subject the public officer to possible removal from office.

EXECUTIVE ORDER NO. 11-84  
AMENDMENT NO. 1

By the power vested in me, I, W. Wilson Goode, as Mayor of the City of Philadelphia, do hereby order that Executive Order No. 11-84, dated July 2, 1984 be amended as follows:

Add in its place the following: "Accordingly, I hereby order that Cabinet members and their deputies, Commissioners and their deputies, members of the Mayor's Office and all members of Boards and Commissions who receive more than twenty-five dollars (\$25) per meeting or who are paid on an annual basis, shall publicly report the following information for themselves and their immediate families:"

This amendment shall be effective immediately and shall apply to the filing of Financial Interest Statements covering calendar year 1985 and succeeding years.

**AMENDMENT NO.2**

By the power vested in me, I, W. Wilson Goode, as Mayor of the City of Philadelphia, do hereby order that Executive Order No. 11-84, dated July 2, 1984, be amended as follows:

**Delete:** The third (3rd) sentence in the first (1st) paragraph:  
"Accordingly, I hereby order that Cabinet members and their deputies, Commissioners and their deputies, members of the Mayor's Office and all members of Boards and Commissions who receive more than twenty-five dollars (\$25) per meeting or who are paid on an annual basis, shall publicly report the following for themselves and their immediate families:"

**Add in its place the following:**

"Accordingly, I hereby order that Cabinet members and their deputies, Commissioners and their deputies, members of the Mayor's Office and all members of Boards and Commissions who receive more than forty dollars (\$40) per meeting or who are paid on an annual basis, shall publicly report the following information for themselves and their immediate families:"

This amendment shall be effective January 4, 1988 and shall apply to the filing of Financial Interest Statements covering calendar year 1987 and succeeding years.
