**The following are the titles of
Bills introduced in City Council
on April 28, 2005**

Bill No. 050337: “An Ordinance authorizing the Commissioner of Public Property and the Director of Commerce, acting on behalf of The City of Philadelphia to enter into a lease agreement with Tincum Township, Delaware County, for the lease from Tincum Township of an approximately 21.8 acre parcel of land adjacent to Philadelphia International Airport which is currently intended for use as a safety area at the end of a runway, under certain terms and conditions.”

Bill No. 050338: “An Ordinance authorizing the Commissioner of Public Property to execute and deliver to the Philadelphia Authority for Industrial Development a deed conveying, for nominal consideration, fee simple title to certain tracts of City-owned land located at 2227-2251 Island Avenue and 7280-7282 Saybrook Avenue, with the buildings and improvements thereon, for further conveyance at fair market value.”

Bill No. 050339: “An Ordinance to amend the Philadelphia Zoning Maps by changing the zoning designations of certain areas of land located within an area bounded by Bridge Street, Tacony Street, a line 245 feet north of Sanger Street, the Delaware River and the Frankford Creek.”

Bill No. 050340: “An Ordinance authorizing the Commissioner of Public Property to execute and deliver to the Philadelphia Authority for Industrial Development a deed conveying, for nominal consideration, fee simple title to a certain parking lot approximately 130 feet in depth along the southern side of West Westmoreland Street between Mascher Street and Howard Street, with the improvements thereon, for further conveyance at fair market value.”

Bill No. 050341: “An Ordinance amending Title 14 of The Philadelphia Code, entitled ‘Zoning and Planning,’ by amending Chapter 14-1600, entitled ‘Miscellaneous,’ by adding a new Section entitled, ‘Lower and Central Germantown Special District Controls,’ all under certain terms and conditions.”

Bill No. 050342: “An Ordinance amending Chapter 10-1800 of The Philadelphia Code entitled ‘Vicarious Liability for Student Conduct,’ by amending the definitions of Educational Housing District to include the Eighth Councilmanic District.”

Bill No. 050343: “An Ordinance authorizing the Philadelphia Authority for Industrial Development (‘PAID’) to file an application with the Office of the Budget, Commonwealth of Pennsylvania, under the Redevelopment Assistance Capital Program, in an

amount not to exceed Five Hundred Thousand Dollars (\$500,000) to assist in the renovation and expansion of the Roxborough YMCA facility; and authorizing the City to enter into an agreement with PAID in furtherance of grant requirements; all under certain terms and conditions.”

Bill No. 050344: “An Ordinance providing for the submission to the qualified electors of the City of Philadelphia of an amendment to the Philadelphia Home Rule Charter regarding City Council approval of rates and charges fixed by the Water Department for supplying water and sewage disposal services, as approved by Resolution of the City Council; fixing the date of a special election for such purpose; prescribing the form of ballot questions to be voted on; and authorizing the appropriate officers to publish notice and to make arrangements for the special election.”

Bill No. 050345: “An Ordinance authorizing designated City officials to file articles of incorporation for a new not-for-profit corporation for the purpose of providing tax relief to certain homeowners who experience burdensome real estate tax bills; authorizing the Director of Finance to enter into an agreement with such corporation for such purpose; and providing for the funding of such an agreement; all under certain terms and conditions.”

Bill No. 050346: “An Ordinance amending Section 14-1629 of The Philadelphia Code, entitled ‘Yorktown Special District Controls’ by specifically amending section 14-1629(3) entitled
