**The following are the titles of
Bills introduced in City Council
on June 16, 2005**

Bill No. 050650: “An Ordinance establishing a parking regulation on Fitzwater street, north side, Broad street to 15th street.”

Bill No. 050651: “An Ordinance establishing a parking regulation on Opal street, west side, Dickinson street to Tasker street.”

Bill No. 050652: “An Ordinance establishing a parking regulation on the south side of Oregon avenue on the north, the east side of 7th street on the east, the approach to the Walt Whitman Bridge on the south and the east side of Broad street on the west.”

Bill No. 050653: “An Ordinance establishing a parking regulation on Powelton avenue, north side, Wiota street to Budd street, Powelton avenue, south side, Preston street to Budd street.”

Bill No. 050654: “An Ordinance establishing a parking regulation on 46th

street, both sides, Osage avenue to Pine street.”

Bill No. 050655: “An Ordinance revising parking regulations on Osage avenue, both sides, from 43rd street to 44th street.”

Bill No. 050656: “An Ordinance establishing a parking regulation on 32nd street, both sides, Hamilton street to Spring Garden street.”

Bill No. 050657: “An Ordinance establishing a parking regulation on Spring Garden street, both sides, 37th street to 38th street.”

Bill No. 050658: “An Ordinance establishing a parking regulation on Baring street, both sides, 37th street to 38th street.”

Bill No. 050659: “An Ordinance establishing a parking regulation on 15th street, both sides, Bainbridge street to Catharine street.”

Bill No. 050660: “An Ordinance approving the third amendment of the redevelopment proposal for the 44th and Aspen Urban Renewal Area, being the area generally bounded by Lancaster Avenue, Belmont Avenue, Pennsgrove Street, 42nd Street, Westminster Avenue, Holly Street, Aspen Street, 40th Street, Haverford Avenue, 44th Street, Fairmount Avenue and 47th Street, including the third amendment to the urban renewal plan and the first amended relocation plan, which provides, *inter alia*, for the additional land acquisition of approximately three hundred seventy four (374) properties for residential and related uses, the additional land acquisition of

approximately three (3) properties for commercial and related uses, the expansion of the eastern border from Forty-second street to Fortieth street between Haverford avenue and Aspen street and from Forty-second street to North Holly street between Aspen street and Westminster avenue; the provision of certain relocation services, as required by law; and declaring that condemnation is not imminent with respect to the Project.”

Bill No. 050661: “An Ordinance authorizing the creation of a loan or loans to provide funds for and toward various capital municipal purposes; authorizing the Mayor, City Controller and City Solicitor or a majority of them to sell bonds at public or private negotiated sale; setting forth the capital purposes and the amounts for which the proceeds of the loan or loans will be expended, including reimbursement of City capital expenditures; providing for the maturities and for other terms and conditions and for the form of the bonds; providing that certain bonds may be redeemable prior to maturity; providing sinking funds for the bonds and for appropriations to the Sinking Fund Commission for the payment thereof; authorizing agreements to provide credit or payment or liquidity sources for the bonds and interest rate swaps in connection with issuance of the bonds, and certain other actions; providing for obtaining the consent of the electors to increasing the indebtedness of the City of Philadelphia; and fixing a day for holding the election for obtaining such consent and providing for the arrangements for holding such election.”

Bill No. 050662: “An Ordinance establishing a parking regulation on 5th

street, both sides, Lehigh avenue to Indiana avenue.”

Bill No. 050663: “An Ordinance establishing a parking regulation on Cayuga street, north side, Malta street to H street.”

Bill No. 050664: “An Ordinance establishing a parking regulation on Griscom street, both sides, Oxford avenue to Arrott street.”

Bill No. 050665: “An Ordinance establishing a parking regulation on Marvine street, both sides, Spencer street to Champlost street.”

Bill No. 050666: “An Ordinance establishing a parking regulation on Venango street, both sides, 15th street to 16th street.”

Bill No. 050667: “An Ordinance establishing a parking regulation on Stanton street, both sides, Frederick street to Ridge avenue.”

Bill No. 050668: “An Ordinance establishing a parking regulation on Ridge avenue, east side, Midvale avenue to Stanton street. Midvale avenue, south sides, Ridge avenue to Creswell street, Midvale avenue, north side, Ridge avenue to Frederick street.”

Bill No. 050669: “An Ordinance amending Section 19-2604 of The Philadelphia Code, relating to tax rates, credits and alternative tax computation for the business privilege tax, by reducing certain tax rates; all under certain terms and conditions.”

Bill No. 050670: “An Ordinance granting permission to Center City

ERUV Corporation, in order to demarcate the boundaries of a Center City eruv district, to construct and maintain a clear nylon cord and other ancillary facilities including a maximum of ten poles along, over, and in certain public rights-of-way and City streets, and/or to attach such demarcation facilities to existing facilities owned by other entities authorized by other City ordinances, subject to such owner's consent; all under certain terms and conditions."

Bill No. 050671: "An Ordinance granting permission to Abbay V. Sheth, owner of the newsstand at the Northwest corner of 12th Street and Filbert Street, to construct, use and maintain an electrical conduit with an electrical service line and a telecommunications conduit with a telephone service line in and under the public rights-of-way for the purpose of supplying electrical service and telephone service to the newsstand, under certain terms and conditions."

Bill No. 050672: "An Ordinance establishing a parking regulation on Wolf street, both sides 12th street to 13th street."

Bill No. 050673: "An Ordinance establishing a parking regulation on 12th street, both sides, Shunk street to Oregon avenue."

Bill No. 050674: "An Ordinance establishing a parking regulation on Christian street, both sides, 7th street to 8th street."

Bill No. 050675: "An Ordinance establishing a parking regulation on

Marvine street, east side, Bainbridge street to Catharine street."

Bill No. 050676: "An Ordinance establishing a parking regulation on 13th street, both sides, wolf street to Ritner street."

Bill No. 050677: "An Ordinance establishing a parking regulation on Allen street, west side, Brady street to Frankford avenue."

Bill No. 050678: "An Ordinance establishing a parking regulation on Christian street, both sides, 12th street to 13th street."

Bill No. 050679: "An Ordinance establishing a parking regulation on Fitzgerald street, south side, 12th street to 13th street."

Bill No. 050680: "An Ordinance establishing a parking regulation on Lawrence street, both sides, Vine street to Wood street."

Bill No. 050681: "An Ordinance establishing a parking regulation on Christian street, north side, 13th street to Broad street."

Bill No. 050682: "An Ordinance establishing a parking regulation on 12th street, east side, Fitzwater street to Catharine street."

Delhi street, Catharine street, north side, Percy street to Delhi street.”

Bill No. 050686: “An Ordinance establishing a parking regulation on Ellsworth street, both sides, broad street to 13th street.”

Bill No. 050687: “An Ordinance establishing a parking regulation on Catharine street, south side, 13th street to Broad street.”

Bill No 050688: “An Ordinance establishing a parking regulation on Jackson street, south side, 11th street to 12th street.”

Bill No. 050689: “An Ordinance establishing a parking regulation on Catharine street, north side, 11th street to 12th street.”

Bill No. 050690: “An Ordinance establishing a parking regulation on Hutchinson street, east side, Catharine street to Christian street.”

Bill No. 050691: “An Ordinance establishing a parking regulation on Catharine street, south side, 10th street to 11th street, Catharine street, north side, Warnock street to 11th street.”

Bill No. 050692: “An Ordinance establishing a parking regulation on 12th street, west side, Bainbridge street to Fitzwater street.”

Bill No. 050693: “An Ordinance establishing a parking regulation on

Catharine street, south side, 12th street to 13th street.”

Bill No. 050694: “An Ordinance establishing a parking regulation on 12th street, west side, Allegheny avenue to Sedgley street.”

Bill No. 050695: “An Ordinance establishing a parking regulation on North street, north side, 18th street to 19th street.”

Bill No. 050696: “An Ordinance revising parking regulations on Aspen street, both sides, from 26th street to 27th street.”

Bill No. 050697: “An Ordinance providing for the submission to the qualified electors of the City of Philadelphia of the proposal set forth in a Resolution approved by Council proposing an amendment of the Philadelphia Home Rule Charter relating to the transfer of the powers and duties of the Fairmount Park Commission to the Department of Recreation (to be renamed the ‘Department of Parks and Recreation’) and reconstituting the Fairmount Park Commission as the Commission on Parks and Recreation, with new powers and duties; and authorizing the appropriate officers to publish notice and to make arrangements for the special election.”
