

EXECUTIVE ORDER NO. 1-88

WHEREAS, Developing an effective transportation program is of critical importance to the City of Philadelphia; and

WHEREAS, Developing a coordinated transportation policy, and establishing a focal point for transportation-related issues require the transfer of policy, planning and coordination functions from the Managing Director, the Department of Public Property, and the Department of Streets to a single Office of Transportation, so that the City speaks with a single voice in matters concerning transportation; and

WHEREAS, the Office of Transportation must receive the highest organizational status, both in recognition of the importance of transportation to the citizens of the City, and to enable the Office to work most effectively with federal and state transportation officials and funding and regulatory bodies;

NOW, THEREFORE, I, W. WILSON GOODE, by the power vested in me as Mayor of the City of Philadelphia, do hereby **ORDER** as follows:

SECTION 1. ESTABLISHMENT OF THE OFFICE OF TRANSPORTATION.

The Office of Transportation is hereby established within the Office of The Mayor. The Office of Transportation shall be headed by the Director of the Office of Transportation. The Director of the Office of Transportation shall report to the Mayor.

SECTION 2. PURPOSE.

The purpose of the Office of Transportation shall be:

- (a) To act as an advocate for transportation policies in the best interests of the City of Philadelphia; and
- (b) To act as a focal point for all transportation-related issues and activities.

SECTION 3. FUNCTIONS.

The functions of the Office of Transportation shall include:

- (a) To advise, recommend and implement the transportation agenda of the City of Philadelphia;
- (b) To represent and further the transportation agenda with and among funding and regulatory agencies such as the Urban Mass Transportation Administration, and Pennsylvania Department of Transportation and the Federal Highway Administration;
- (c) To recommend to the Mayor and the Cabinet and to promote transportation projects essential to economic development in the City and the region;
- (d) To establish and lead a regional transportation forum;
- (e) To communicate transportation concerns, policies and project development to the community and the region;
- (f) To facilitate the exchange of information concerning transportation planning functions among federal, state and local agencies;
- (g) To represent the Administration on all transportation-related committees and other bodies, whether or not governmental;
- (h) To conduct research concerning transit planning and projects;

- (i) To prepare grant applications for federal and state funding of transportation projects in conjunction with sponsor departments of the City; and
- (j) To oversee implementation of Administration policy by the operating departments and agencies.

SECTION 4. EFFECTIVE DATE.

This ORDER shall be effective as of January 4, 1988.
