COMMISSION ON ASIAN AMERICAN AFFAIRS

I, W. WILSON GOODE, by the power vested in me by the Philadelphia
~~Home Rule Charter, do hereby ORDER:~~

SECTION 1. Establishment of Mayor's Commission on Asian American
Affairs;

Membership.

There is hereby established in the Mayor's Office the
Commission on Asian American Affairs. The Commission shall
consist of thirteen (13) members (or such other number, as the
Mayor may determine, from time to time), appointed by the Mayor,
and shall serve at the pleasure of the Mayor.

SECTION 2. Functions.

The Commission shall:

- (a) Bring the concerns and needs of Asian Americans to the
attention of City government and community groups;
- (b) Disseminate to Asian Americans information about City
programs that are available for their benefit;
- (c) Develop recommendations to increase the City
government's accountability to the Asian American
community;
- (d) Serve as a communication channel between Asian
Americans and the City government and various City
minority groups, to counter misinformation,
misconceptions, stereotypes and myths;

- (e) Promote cooperation among Asian Americans, other ethnic groups, and the population at large;
- (f) Develop recommendations to protect and preserve the civil rights of Asian Americans, and to defend Asian Americans from all forms of discrimination;
- (g) Develop recommendations to promote the hiring of Asian Americans by City departments and their appointment to decision-making bodies;
- (h) Develop recommendations to improve the City's educational programs for Asian Americans; and
- (i) Perform such other advisory duties as the Mayor may request.

EXECUTIVE ORDER NO. 8-90

WHEREAS, all citizens have a right to expect effective and efficient government; and

WHEREAS, the existing financial situation warrants actions of a cost savings nature; and

WHEREAS, actions must be taken to ensure the continuation of City services under existing financial constraints;

NOW, THEREFORE, I, W. WILSON GOODE, by the power vested in me as Mayor of the City of Philadelphia, do hereby **ORDER** that:

Effective immediately there will be an overall reduction in the size and use of the City of Philadelphia sedan fleet. This is to include all departments and agencies under the jurisdiction of the Mayor. The fleet use and reduction program will consist of two phases:

- 1) At a time and place designated by the Managing Director, each department or agency will be required to turn in to the Department of Public Property a designated number of vehicles. The loss of these vehicles will be permanent and will effectuate savings throughout the City, in both operating and maintenance costs.

- 2) Effective immediately, all vehicular take-home privileges are restricted in a manner prescribed by the Managing Director. This shall apply to all employees of the City of Philadelphia under the jurisdiction of the Mayor.
