

## 1. Definitions

**Incidental Project:** Abatement of less than 1 linear or 5 square feet.

**Major Project, Permitted:** Abatement greater than or equal to 40 linear or 80 square feet. A Major Project must have a permit approved and issued by the Department of Public Health.

**Major Project, Non – Permitted:** Any demolition project except single residences with three dwelling units or less where there is no asbestos present.

**Minor Project:** Abatement greater than or equal to 3 linear or 12 square feet but less than 40 linear or 80 square feet

**NESHAP Project:** Abatement greater than or equal to 260 linear or 160 square feet.

**Small Project:** Abatement greater than or equal to 1 linear or 5 square feet but less than 3 linear or 12 square feet

## 2. Permit and Filing Fees:

| Major Project, Non-Permitted          | Demolition   | none       | none  | 10 Working Days              |
| Minor Project                         | Abatement    | \$25       | none  | 5 Calendar Days <sup>1</sup> |
| Small Project                         | Abatement    | none       | none  | 5 Calendar Days <sup>1</sup> |
| Incidental                            | Courtesy     | none       | none  | none                         |
| Non-Friable <sup>2</sup>              | Courtesy     | none       | none  | n/a                          |
| Alternative Method request            | n/a          | \$25       | none  | n/a                          |

<sup>1</sup>Twenty-four hours if hand delivered

<sup>2</sup>Non-Friable floor tile abatement requires Notification and a \$25 Alternative Method Request fee to do the job as non-friable, but requires no Permit or Filing fees.

**All Other Projects:** Notification to the Department of Labor and Industry is required for ALL friable and non-friable projects of any size.

**Note:** Air Management Services will forward all City of Philadelphia notifications to the appropriate State of Pennsylvania agency.

**Notification to EPA:** It is the Contractors responsibility to submit notification to the EPA for renovation projects regulated under the asbestos NESHAP and for all demolition projects.
