Agenda Item #1 - Approval of Minutes of November 7, 2013

Ms. Cherry informed the Board that the Socially Responsible Funds would be added to the Fund line-up on December 13, 2013. Staff would present the performance report for the 4th Quarter in February.

Mr. Nyce said for the month of November, there were 17,127 participants in the Plan. There were 81 enrollments for the month of October. Total Plan assets were \$788,077,265. He noted that as of the end of November, the Fund had crossed the \$800 million mark. He will report more on that in December.

Mr. Stagliano said that on November 21, 2013, there was a Retirement Seminar at the Fraternal Order of Police, and Mr. Bielli, Mr. Murphy, Mrs. Graves, Ms. Talaferro and Ms. Thomas did a great job. There were over 200 people at the seminar. Mr. Nyce arrived before the seminar and remained throughout the day. He responded to questions.

Mr. Stagliano thanked the Pension Staff and Mr. Nyce for helping him and a deceased female Police Officer's family when they came to the Board last week.
