

EXECUTIVE ORDER NO. 3-08
RELATING TO THE SUPERVISION OF, AND COORDINATION AMONG, THE
CITY'S DEPARTMENTS, BOARDS AND COMMISSIONS
(As amended September 25, 2014)

BACKGROUND

WHEREAS, the supervision of, and coordination among, the City's Departments, Boards and Commissions is entrusted to the Mayor and the members of the cabinet;

WHEREAS, coordination and cooperation among the officials and heads of the City's Departments, Boards and Commission is essential to the proper management of the executive branch of city government;

WHEREAS, in order to facilitate supervision of, and coordination among, the Departments, Boards and Commissions of the City, Deputies in the offices of the Mayor and the Managing Director should be assigned to work with specific Departments, Boards and Commissions;

WHEREAS, in order to best leverage the specialized experience, education and expertise of the Deputies, as well as to promote cross-departmental and inter-agency cooperation, the Deputies should work with a grouping of Departments, Boards and Commissions organized by common subject matter;

NOW THEREFORE, by the power vested in me as Mayor of the City of Philadelphia, it is hereby ordered:

SECTION 1. The Managing Director

The Managing Director shall report directly to the Mayor and, in addition to the duties and responsibilities set forth in the City Charter, shall perform the duties set forth in Section 4 hereof. The Managing Director shall also serve as a Deputy Mayor.

SECTION 2. The Commerce Director

The Commerce Director shall report directly to the Mayor and, in addition to the duties and responsibilities set forth in the City Charter, shall perform the duties set forth in Section 8 thereof . The Commerce Director shall also serve as a Deputy Mayor and shall be designated as the Commerce Director/Deputy Mayor for Planning and Economic Development.

SECTION 3. Deputy Mayors and Deputy Managing Directors

In addition to such other Deputies as may from time to time be appointed, there shall be Deputy Mayors who will also serve Deputy Managing Directors. Initially there will be three Deputy Mayors/Deputy Managing Directors, designated as follows: one shall be designated the Deputy Mayor and Deputy Managing Director for Public Safety, one shall be designated the Deputy Mayor and Deputy Managing Director for Health and Opportunity, and one shall be designated the Deputy Mayor and Deputy Managing Director for Transportation and Utilities. The Deputy Mayors/Deputy Managing Directors shall report to both the Mayor and the Managing Director and shall perform the duties set forth in Sections 5 to 7 hereof, respectively.

SECTION 4. Managing Director/Deputy Mayor

The Managing Director/Deputy Mayor shall:

- (1) Supervise and coordinate as appropriate the operations of all departments, agencies, boards, offices, committees and commissions as provided in the City Charter.
- (2) Work with the Deputy Mayors in coordination with the Finance Director to ensure the implementation of Mayoral policies and initiatives, including Citistat and 311.
- (3) Represent the Mayor, when so directed by the Mayor, on any board, committee, commission or corporation of which the Mayor is a member.
- (4) Perform such other duties as the Mayor may direct.

SECTION 5. Deputy Mayor/Deputy Managing Director for Public Safety

The Deputy Mayor/Deputy Managing Director for Public Safety shall:

- (1) Advise and assist the Mayor and Managing Director on all policies, planning, resource allocation, budgeting and initiatives designed to promote the public safety and prevent crime.
- (2) Coordinate and collaborate with the Police and Fire departments, the Philadelphia Prison System, and the Department of Licenses and Inspections. Supervise the Department of Licenses and Inspections, and supervise the Police and Fire departments and the Philadelphia Prison system as necessary. Monitor and analyze their performance and progress, and encourage cooperation and collaboration.
- (3) Maintain liaison with and review the activities of the Courts, District Attorney's and Sheriff's offices, Probation Department and Community Court.
- (4) Coordinate and maintain liaison with the Boards and Commissions, City-related agencies, authorities and quasi-governmental entities identified in Exhibit A.
- (5) Work with the other Deputy Mayors in coordination with the Finance Director and the Managing Director to approve or recommend approval of budgets and to ensure the appropriate allocation of resources and the implementation of Mayoral policies and initiatives, including emergency management and L&I policies.
- (6) Represent the Mayor or Managing Director, when so directed by the Mayor or Managing Director, on any board, committee, commission or corporation of which the Mayor or the Managing Director is a member.
- (7) Perform such other duties as the Mayor or Managing Director may direct.

SECTION 6. Deputy Mayor/Deputy Managing Director for Health and Opportunity

The Deputy Mayor/Deputy Managing Director for Health and Opportunity shall:

- (1) Advise and assist the Mayor and Managing Director on all policies, planning, resource allocation, budgeting and initiatives designed to promote the health, well-being and self-sufficiency of the citizens of Philadelphia.
- (2) Supervise and coordinate the departments of Human Services, Health and Behavioral Health/Mental Retardation Services as well as all offices related to homelessness and housing assistance and re-entry services for ex-offenders. Monitor and analyze the departments' performance and progress, and encourage cooperation and collaboration.
- (3) Maintain liaison with and review the activities of the School District.
- (4) Coordinate and maintain liaison with the Boards and Commissions, City-related agencies, authorities and quasi-governmental entities identified in Exhibit A.
- (5) Work with the other Deputy Mayors in coordination with the Finance Director and the Managing Director to approve or recommend approval of budgets and to ensure the appropriate allocation of resources and the implementation of Mayoral policies and initiatives, including homeless and housing assistance and prisoner re-entry.
- (6) Represent the Mayor or Managing Director when so directed by the Mayor or the Managing Director, on any board, committee, commission or corporation of which the Mayor or the Managing Director is a member.
- (7) Perform such other duties as the Mayor or Managing Director may direct.

SECTION 7. Deputy Mayor/Deputy Managing Director for Transportation and Utilities

The Deputy Mayor/Deputy Managing Director for Transportation and Utilities shall:

- (1) Advise and assist the Mayor and Managing Director on and coordinate all

policies, planning, resource allocation, budgeting and initiatives relating to transportation, waste management, infrastructure and public utilities.

(2) Supervise and coordinate the Department of Streets, Department of Water and the Department of Airport.

(3) Serve as one of the Mayor's two appointees on the SEPTA Board.

(4) Coordinate and maintain liaison with the Boards and Commissions, City-related agencies, authorities and quasi-governmental entities identified in Exhibit A.

(5) Work with the other Deputy Mayors in coordination with the Finance Director and the Managing Director to approve or recommend approval of budgets and to ensure the appropriate allocation of resources and the implementation of Mayoral policies and initiatives, including city planning and waterfront development.

(6) Represent the Mayor or the Managing Director when so directed by the Mayor or the Managing Director, on any board, committee, commission or corporation of which the Mayor or the Managing Director is a member.

(7) Perform such other duties as the Mayor or Managing Director may direct.

SECTION 8. Commerce Director/Deputy Mayor for Planning and Economic Development

The Commerce Director/Deputy Mayor for Planning and Economic Development shall:

(1) Advise and assist the Mayor and Managing Director on all policies, planning, resource allocation, budgeting and initiatives designed to foster the economic development of the City, including those related to the City's overall business climate; the attraction, retention and expansion of business enterprises; workforce development and neighborhood economic revitalization; retention of college graduates; minority business development; efforts to secure unique events; commercial, industrial and residential development; waterfront development;

foreign trade and investment; film, theater and broadcasting; arts and culture; and tourism.

(2) Supervise and coordinate Commerce, Housing, the Office of the City Representative and the City Planning Commission. Direct and coordinate the activities of all administrations, departments, agencies, boards, offices, committees and commissions with respect to economic development policies, planning and programs. The Commerce Director/Deputy Mayor shall further maintain liaison with the Deputy Mayor for Public Safety on matters relating to planning, zoning, real estate development, and business licensing that are within the purview of the Department of Licenses and Inspections.

(3) Maintain liaison with and review the activities of governmental and non-governmental agencies and offices with respect to matters of City economic development policies and programs.

(4) Coordinate and maintain liaison with the Boards and Commissions, City-related agencies, authorities and quasi-governmental entities identified in Exhibit A.

(5) Work with other Deputy Mayors in coordination with the Finance Director and the Managing Director to approve or recommend approval of budgets and to ensure the appropriate allocation of resources and the implementation of Mayoral policies and initiatives, including workforce development, the airport and airport facilities, and the port and the wharf, dock and harbor facilities.

(6) Represent the Mayor or the Managing Director when so directed by the Mayor or the Managing Director, on any board, committee, commission or corporation of which the Mayor or the Managing Director is a member.

(7) Perform such other duties as the Mayor or Managing Director may direct.

SECTION 9. Memoranda of Understanding

(1) The Managing Director and the Commerce Director expect to enter a Memorandum of Understanding (attached as Exhibit B) pursuant to which the Managing Director will supervise the operation of the airport and airport facilities, and the port and the wharf, dock and harbor facilities. That Memorandum of Understanding is approved.

(2) The Managing Director and the Finance Director expect to enter a Memorandum of Understanding (attached as Exhibit C) pursuant to which the Managing Director will supervise the Procurement Department. That Memorandum of Understanding is approved.

(3) The Mayor shall be notified in advance of termination of any of the foregoing Memoranda of Understanding.


SECTION 10. City Solicitor Review




This Memorandum of Understanding ("MOU") is made as of the 7th day of January, 2008, by and between the Managing Director of the City of Philadelphia and the Commerce Director of the City of Philadelphia.

In consideration of the specialized experience, education and expertise of the members of the executive branch of city government and to effectively promote the cross-departmental and inter-agency cooperation needed for the effective function of city government and in order that Section 8-401 of the Philadelphia Home Rule Charter ("Charter") is properly complied with, the Managing Director of the City of Philadelphia and the Commerce Director of the City of Philadelphia agree to the following:

1. Day to day supervision of the functions of the Airport, Airport Facilities and Airport Advisory Board (collectively, the "Airport") and the Port and the Wharf, Dock and Harbor Facilities (collectively, the "Port") is hereby assigned to the Managing Director and will be performed in the first instance by the Deputy Mayor/Deputy Managing Director for Transportation and Utilities.
2. The Commerce Director will retain the ultimate power to supervise employees and activities of the Airport and Port and to see that all activities with respect thereto are duly carried out.
3. This Memorandum of Understanding is effective immediately.


1. Day to day supervision of the Procurement Department is hereby assigned to the Managing Director and will be performed in the first instance by the Deputy Managing Director for Operations.

In addition to such other Deputies as may from time to time be appointed, there shall be Deputy Mayors who will also serve Deputy Managing Directors. Initially there will be three Deputy Mayors/Deputy Managing Directors, designated as follows: one shall be designated the Deputy Mayor and Deputy Managing Director for Public Safety, one shall be designated the Deputy Mayor and Deputy Managing Director for Health and Opportunity, and one shall be designated the Deputy Mayor and Deputy Managing Director for Transportation and Utilities. The Deputy Mayors/Deputy Managing Directors shall report to both the Mayor and the Managing Director and shall perform the duties set forth in Sections 5 to 7 hereof, respectively.

(5) Work with the other Deputy Mayors in coordination with the Finance Director and the Managing Director to approve or recommend approval of budgets and to ensure the appropriate allocation of resources and the implementation of Mayoral policies and initiatives, including homeless and housing assistance and prisoner re-entry.

(4) Coordinate and maintain liaison with the Boards and Commissions, City-related agencies, authorities and quasi-governmental entities identified in Exhibit A.

(5) Work with the other Deputy Mayors in coordination with the Finance Director and the Managing Director to approve or recommend approval of budgets and to ensure the appropriate allocation of resources and the implementation of Mayoral policies and initiatives, including city planning and waterfront development.

(6) Represent the Mayor or the Managing Director when so directed by the Mayor or the Managing Director, on any board, committee, commission or corporation of which the Mayor or the Managing Director is a member.

(2) Supervise and coordinate Commerce, Housing, ~~Licenses & Inspection~~, the Office of the City Representative and the City Planning Commission. Direct and coordinate the activities of all administrations, departments, agencies, boards, offices, committees and commissions with respect to economic development policies, planning and programs. **The Commerce Director/Deputy Mayor shall further maintain liaison with the Deputy Mayor for Public Safety on matters relating to planning, zoning, real estate development, and business licensing that are within the purview of the Department of Licenses and Inspections.**

(3) Maintain liaison with and review the activities of governmental and non-governmental agencies and offices with respect to matters of City economic development policies and programs.

(4) Coordinate and maintain liaison with the Boards and Commissions, City-related agencies, authorities and quasi-governmental entities identified in Exhibit A.

SECTION 9. Memoranda of Understanding

(1) The Managing Director and the Commerce Director expect to enter a Memorandum of Understanding (attached as Exhibit B) pursuant to which the Managing Director will supervise the operation of the airport and airport facilities, and the port and the wharf, dock and harbor facilities. That Memorandum of Understanding is approved.

(2) The Managing Director and the Finance Director expect to enter a Memorandum of Understanding (attached as Exhibit C) pursuant to which the Managing Director will supervise the Procurement Department. That Memorandum of Understanding is approved.

(3) The Mayor shall be notified in advance of termination of any of the foregoing Memoranda of Understanding.

SECTION 10. City Solicitor Review

(1) The City Solicitor shall promptly review Exhibit A to ensure that the list of Boards and Commissions, City-related agencies, authorities and quasi-governmental entities is complete and current and to make recommendations to the Mayor for additions and revisions to Exhibit A.

SECTION 11. Effective Date.

This Order shall take effect immediately.




