SETTLEMENT AGREEMENT

This Settlement Agreement ("Agreement") is made and entered into by the Board of Ethics of the City of Philadelphia, J. Shane Creamer, Jr., the Executive Director of the Board, Friends of Cindy Bass, and Traci Nickens, the Treasurer of Friends of Cindy Bass, jointly referred to as "the Parties."

RECITALS


- A. The Board of Ethics of the City of Philadelphia is an independent, five-member City board established in 2006 through voter approval of an amendment to the Philadelphia Home Rule Charter. Pursuant to Section 4-1100 of the Home Rule Charter, the Board is charged with administering and enforcing the City's Campaign Finance Law.
- B. The Honorable Cindy Bass is the City Council member representing the 8th Council District in Philadelphia. She was a candidate for City Council in the 8th Council District in the 2019 Democratic Primary Election and the 2019 General Election. Ms. Bass registered and authorized Friends of Cindy Bass as the candidate political committee to receive contributions and make expenditures on behalf of her candidacy. Traci Nickens is the Treasurer of Friends of Cindy Bass.
- C. Pursuant to the City's Campaign Finance Law, at various points candidate political committees must file with the Board campaign finance reports, which disclose details of their financial transactions for the relevant reporting period. Board Regulation, No. 1, Paragraph 1.23(a)(iii) requires that each purchase made by a campaign credit card be itemized and disclosed as an expenditure.
- D. Pursuant to Philadelphia Code § 20-1006(4) and Regulation No. 1, Paragraph 1.24, the making of a material misstatement or omission in a report filed with the Board is a violation of the City's Campaign Finance Law.
- E. In November of 2019, Board Enforcement Staff conducted a review of campaign finance filings that revealed potential violations of the City's Campaign Finance Law by Friends of Cindy Bass. Accordingly, the Executive Director opened an investigation during which Enforcement Staff reviewed bank records and spoke with individuals associated with the Bass campaign.
- F. From January 1, 2019 through October 25, 2019, Friends of Cindy Bass used a credit card held in its name with the Philadelphia Federal Credit Union to make 125 campaign expenditures totaling \$16,636.80. None of the campaign credit card's expenditures were disclosed in any 2019 campaign finance reports filed by the Bass campaign with the Board. The omitted expenditures are attached to the Agreement as Exhibit A.
- G. Friends of Cindy Bass fully cooperated with the Board's investigation. It has filed amended 2019 campaign finance reports with the Board in order to disclose the credit card expenditures described in Paragraph F.
- H. The Parties desire to enter into this Agreement in order to resolve the issues described herein.

AGREEMENT

The Parties agree that:

- 1. By failing to disclose its credit card expenditures in campaign finance reports that it filed with the Board in 2019, Friends of Cindy Bass and Traci Nickens violated Philadelphia Code § 20-1006(4), for which they are jointly and severally liable for a civil monetary penalty of \$2,000, which shall be due within 30 days of the effective date of the Agreement.
 - Payment shall be made by check or money order made payable to the City of Philadelphia and delivered to the offices of the Board of Ethics.
- 2. Friends of Cindy Bass and Ms. Nickens release and hold harmless the Board and its staff from any potential claims, liabilities, and causes of action arising from the Board's investigation, enforcement, and settlement of the matters described in the Agreement.
- 3. In consideration of the above and in exchange for the compliance of Friends of Cindy Bass and Ms. Nickens with the terms of the Agreement, the Board waives any further penalties or fines against them for the conduct described in the Agreement.
- 4. The Parties will not make any public statements that are inconsistent with the terms of the Agreement.
- 5. If the City is forced to seek judicial enforcement of this Agreement, and prevails, the Friends of Cindy Bass and Ms. Nickens shall be liable for attorneys' fees and costs reasonably expended in enforcing compliance with the Agreement. Fees for time spent by Board or City attorneys shall be calculated based upon standard and customary billing rates in Philadelphia for attorneys with similar experience.
- 6. The Agreement contains the entire agreement between the Parties.
- 7. The Executive Director, or his designee, will submit a signed copy of the Agreement to the Board for approval. The Agreement shall become effective upon approval by the Board.
- 8. If the Board rejects the proposed Agreement, presentation to and consideration of the Agreement by the Board shall not preclude the Board or its staff from participating in, considering, or resolving an administrative adjudication of the matters described in the Agreement. If the Board rejects the proposed Agreement, nothing in the proposed Agreement shall be considered an admission by either party and, except for this paragraph, nothing in the Agreement shall be effective.
