

SETTLEMENT AGREEMENT

This Settlement Agreement (“Agreement”) is made and entered into by the Board of Ethics of the City of Philadelphia, J. Shane Creamer, Jr., the Executive Director of the Board, Kahlil for Philly, and Vikram Patel, the Treasurer of Kahlil for Philly, jointly referred to as “the Parties.”

RECITALS

- A. The Board of Ethics of the City of Philadelphia is an independent, five-member City board established in 2006 through voter approval of an amendment to the Philadelphia Home Rule Charter. Pursuant to Section 4-1100 of the Home Rule Charter, the Board is charged with administering and enforcing the City’s Campaign Finance Law.
- B. Kahlil Williams is a candidate for City Commissioner in the 2019 Democratic Primary Election. On October 9, 2018, Mr. Williams registered and authorized Kahlil for Philly as the candidate political committee to receive contributions and make expenditures on behalf of his candidacy. Vikram Patel is the Treasurer of Kahlil for Philly.
- C. Pursuant to the City’s Campaign Finance Law, candidate political committees must file campaign finance reports at specified times with the Board disclosing transactions related to a covered City election. Pursuant to Philadelphia Code § 20-1006(4) and Regulation No. 1, Paragraph 1.24, the making of a material misstatement or omission in a required report filed with the Board is a violation of the City’s Campaign Finance Law.
- D. In February of 2019, Board Enforcement Staff received information alleging potential violations of the City’s Campaign Finance Law by Kahlil for Philly. Accordingly, the Executive Director opened an investigation during which Enforcement Staff obtained records and spoke with individuals associated with the Williams campaign.
- E. On November 30, 2018, the law firm Davis Polk & Wardwell, LLP (“Davis Polk”) hosted a campaign event for Mr. Williams at its New York office. Davis Polk paid for the food and a server for the event, spending a total of \$836.98. These expenditures by Davis Polk were in-kind contributions to Mr. Williams’ campaign.
- F. Kahlil for Philly filed a 2018 annual (cycle 7) campaign finance report with the Board on January 31, 2019, but failed to disclose in it the in-kind contribution described in Paragraph E.
- G. Kahlil for Philly fully cooperated with the Board’s investigation. It has amended its 2018 annual campaign finance report with the Board to disclose the in-kind contribution described in Paragraph E. A copy of the amended report is attached as Exhibit A.
- H. The Parties desire to enter into this Agreement in order to resolve the issues described herein.

AGREEMENT

The Parties agree that:

1. By making a material omission from the 2018 Cycle 7 campaign finance report that it filed with the Board, Kahlil for Philly and Mr. Patel violated Philadelphia Code § 20-1006(4), for which they are jointly and severally liable for a civil monetary penalty of \$1,000. In recognition of settlement and their cooperation, the penalty is reduced to \$500, which shall be due within 14 days of the effective date of the Agreement.

Payment shall be made by check or money order made payable to the City of Philadelphia and delivered to the offices of the Board of Ethics.

2. Kahlil for Philly and Mr. Patel release and hold harmless the Board and its staff from any potential claims, liabilities, and causes of action arising from the Board's investigation, enforcement, and settlement of the matters described in the Agreement.
3. In consideration of the above and in exchange for the compliance of Kahlil for Philly and Mr. Patel with all of the terms of the Agreement, the Board waives any further penalties or fines against them for the conduct described in the Agreement.
4. The Parties will not make any public statements that are inconsistent with the terms of the Agreement.
5. If the City is forced to seek judicial enforcement of this Agreement, and prevails, Kahlil for Philly and Mr. Patel shall be liable for attorneys' fees and costs reasonably expended in enforcing compliance with the Agreement. Fees for time spent by Board or City attorneys shall be calculated based upon standard and customary billing rates in Philadelphia for attorneys with similar experience.
6. The Agreement contains the entire agreement between the Parties.
7. The Executive Director, or his designee, will submit a signed copy of the Agreement to the Board for approval. The Agreement shall become effective upon approval by the Board.
8. If the Board rejects the proposed Agreement, presentation to and consideration of the Agreement by the Board shall not preclude the Board or its staff from participating in, considering, or resolving an administrative adjudication of the matters described in the Agreement. If the Board rejects the proposed Agreement, nothing in the proposed Agreement shall be considered an admission by either party and, except for this paragraph, nothing in the Agreement shall be effective.




