SETTLEMENT AGREEMENT

This Settlement Agreement ("Agreement") is made and entered into by the Board of Ethics of the City of Philadelphia, J. Shane Creamer, Jr., the Executive Director of the Board, Friends of Rochelle Bilal, and Shirley Jordan, the Treasurer of Friends of Rochelle Bilal, jointly referred to as "the Parties."

RECITALS

- A. The Board of Ethics of the City of Philadelphia is an independent, five-member City board established in 2006 through voter approval of an amendment to the Philadelphia Home Rule Charter. Pursuant to Section 4-1100 of the Home Rule Charter, the Board is charged with administering and enforcing the City's Campaign Finance Law.
- B. Rochelle Bilal is a candidate for Sheriff in the May 21, 2019 Democratic Primary Election. Ms. Bilal registered and authorized Friends of Rochelle Bilal as the candidate political committee to receive contributions and make expenditures on behalf of her candidacy. Shirley Jordan is the Treasurer of Friends of Rochelle Bilal.
- C. Pursuant to the City's Campaign Finance Law, at various points candidate political committees must file with the Board campaign finance reports, which disclose their financial transactions for the reporting period. Pursuant to Philadelphia Code § 20-1006(4) and Regulation No. 1, Paragraph 1.24, the making of a material misstatement or omission in a report filed with the Board is a violation of the City's Campaign Finance Law.
- D. In April of 2019, Board Enforcement Staff received information alleging potential violations of the City's Campaign Finance Law by Friends of Rochelle Bilal. Accordingly, the Executive Director opened an investigation during which Enforcement Staff obtained records and spoke with individuals associated with the Bilal campaign.
- E. On February 22, 2019, Friends of Rochelle Bilal paid \$750 to Docucare Copy Service to print campaign literature, including palm cards. The payment by Friends of Rochelle was an expenditure by Ms. Bilal's campaign. A copy of the palm card is attached as Exhibit A.
- F. On April 9, 2019, Friends of Rochelle Bilal filed a 2019 sixth Tuesday pre-primary (cycle 1) campaign finance report with the Board, but failed to disclose in that report the expenditure described in Paragraph E.
- G. Friends of Rochelle Bilal fully cooperated with the Board's investigation. It has filed an amended cycle 1 campaign finance report in order to correct the omission described in Paragraph E. A copy of the amended report is attached as Exhibit B.
- H. The Parties desire to enter into this Agreement in order to resolve the issues described herein.

AGREEMENT

The Parties agree that:

 By making a material omission from the 2019 Cycle 1 campaign finance report that it filed with the Board, Friends of Rochelle Bilal and Shirley Jordan violated Philadelphia Code § 20-1006(4), for which they are jointly and severally liable for a civil monetary penalty of \$1,000. In recognition of settlement and their cooperation, the penalty is reduced to \$500, which shall be due within 14 days of the effective date of the Agreement.

Payment shall be made by check or money order made payable to the City of Philadelphia and delivered to the offices of the Board of Ethics.

- 2. Friends of Rochelle Bilal and Ms. Jordan release and hold harmless the Board and its staff from any potential claims, liabilities, and causes of action arising from the Board's investigation, enforcement, and settlement of the matters described in the Agreement.
- 3. In consideration of the above and in exchange for the compliance of Friends of Rochelle Bilal and Ms. Jordan with all of the terms of the Agreement, the Board waives any further penalties or fines against them for the conduct described in the Agreement.
- 4. The Parties will not make any public statements that are inconsistent with the terms of the Agreement.
- 5. If the City is forced to seek judicial enforcement of this Agreement, and prevails, Friends of Rochelle Bilal and Ms. Jordan shall be liable for attorneys' fees and costs reasonably expended in enforcing compliance with the Agreement. Fees for time spent by Board or City attorneys shall be calculated based upon standard and customary billing rates in Philadelphia for attorneys with similar experience.
- 6. The Agreement contains the entire agreement between the Parties.
- 7. The Executive Director, or his designee, will submit a signed copy of the Agreement to the Board for approval. The Agreement shall become effective upon approval by the Board.
- 8. If the Board rejects the proposed Agreement, presentation to and consideration of the Agreement by the Board shall not preclude the Board or its staff from participating in, considering, or resolving an administrative adjudication of the matters described in the Agreement. If the Board rejects the proposed Agreement, nothing in the proposed Agreement shall be considered an admission by either party and, except for this paragraph, nothing in the Agreement shall be effective.
