All Philadelphians have access to healthy, affordable, and sustainable food and drinking water

Greenworks is the city's sustainability plan to improve quality of life for all Philadelphians. The City of Philadelphia committed to department actions that advance Greenworks across each of the plan's eight visions. Read on to learn more about progress on each initiative.

2017 HIGHLIGHTS: The Philadelphia Department of Public Health, Procurement Department, and Office of Sustainability received grant funds from the Centers for Disease Control to hire two staff focused on using City dollars to influence the food system - a Good Food Procurement Coordinator and a Healthy Food Procurement Coordinator. The Food Policy Advisory Council in partnership with Philadelphia Parks & Recreation hired local facilitators to gather community input on the scope of a citywide urban agriculture strategic plan.

2017 HIGHLIGHTS: The Philadelphia Department of Public Health with the Children's Hospital of Philadelphia and St. Christopher's Hospital for Children are piloting whole-home health interventions that include assessing and improving indoor air quality. The Office of Sustainability and Office of Fleet Management received funding from the PA Department of Environmental Protection to support the development of a Green Fleets Plan in 2018.

2017 HIGHLIGHTS: In 2017 the Office of Sustainability published the *Municipal Energy Master Plan* and a draft of *Powering Our Future: A Clean Energy Vision* for Philadelphia, which together outline opportunities for the City of Philadelphia to meet the challenge of climate change while improving equity and health for all Philadelphians. The Philadelphia Energy Authority's Solarize Philly campaign helped make going solar affordable for hundreds of Philadelphia residents.

Greenworks is the city's sustainability plan to improve quality of life for all Philadelphians. The City of Philadelphia committed to department actions that advance Greenworks across each of the plan's eight visions. Read on to learn more about progress on each initiative.

2017 HIGHLIGHTS: In response to the decision by the Trump Administration to withdraw from the Paris Climate Agreement, Mayor Kenney re-affirmed our commitment to meeting the goals of the Agreement and signed the Mayors for Clean Energy pledge to transition Philadelphia to 100% clean energy. To help Philadelphians already experiencing the impacts of climate change, the Office of Sustainability received funding to launch a Greenworks Equity Index project focused on extreme heat in 2018.

2017 HIGHLIGHTS: The Philadelphia Water Department installed its 1,000th acre of green stormwater infrastructure which together keep nearly 28 million gallons of polluted runoff out of our rivers during just one inch of rain. Philadelphia Parks & Recreation and the Office of Sustainability began regularly convening organizations working on trees to coordinate and plan how we can work together toward shared goals for the urban forest.

2017 HIGHLIGHTS: The Office of Complete Streets issued Philadelphia's first-ever *Vision Zero Action Plan*, a three-year program to improve traffic safety and save lives. The Office of Transportation and Infrastructure Systems began work on a broader transportation strategy for Philadelphia, and will expand that work with City departments and the public in 2018.

ZERO WASTE

All Philadelphians waste less and keep our neighborhoods clean

Greenworks is the city's sustainability plan to improve quality of life for all Philadelphians. The City of Philadelphia committed to department actions that advance Greenworks across each of the plan's eight visions. Read on to learn more about progress on each initiative.

2017 HIGHLIGHTS: The City set a goal reaching zero waste by 2035, and published the *Zero Waste and Litter Action Plan* to help Philadelphia eliminate street litter and divert waste from landfills. To help achieve these goals, the City debuted Philacycle, a partnership with Recyclebank to reward residents for helping achieve the zero waste vision.
