

Autobody Shop Petition (Exemption) Letter

40 CFR 63 Subpart HHHHHH

This letter is to inform you how to apply for exemption (petition) from the motor vehicle and mobile equipment surface coating requirements of the National Emission Standard for Hazardous Air Pollutants, at Area Sources, 40 C.F.R. Part 63 Subpart HHHHHH.

To obtain an exemption, 40 CFR Section 63.11170(a)(2) requires that as the owner or operator of a motor vehicle surface coating operation you demonstrate, to EPA's satisfaction, that you spray apply no coatings that contain the target HAP, as defined in Section 63.11180. This target HAPs are: chromium (Cr), lead (Pb), nickel (Ni), or cadmium (Cd) in amounts greater than or equal to 0.1 % by mass, and materials that contain manganese (Mn) in amounts greater than or equal to 1.0 % by mass, as shown in formulation data provided by the manufacturer or supplier, such as the Material Safety Data sheet for the material. The petition must include a description of the coatings that you spray apply and your certification that you do not spray apply any coatings containing the target HAP.
