- 1. Enter name of the project and exact address including zip code.
- 2. Enter name of contractor, license number and your business privilege tax license number.

Major Project Permit

- 3. Check initial, amended, or final box. If amended or final enter the project ID number.
- 4. Enter the total cost of abatement. Include all abatement cost (e.g. prep work, disposal, salaries, etc.). Do not include air monitoring or asbestos project inspector costs.
- 5. Enter project cost up to and including fifty thousand dollars.
- 6. Enter three and three quarter percent (3.75%) [x .0375] of the amount indicated inbox #1.
- 7. Enter amount of project that exceeds fifty thousand dollars.
- 8. Enter one and seven eighths percent (1.875%) [x .01875] of the amount indicated in box #2.
