### Position Summary

The Street Tree Management Division (STM) is responsible for the care and maintenance of the street trees throughout the City of Philadelphia. The maintenance of the trees is accomplished through the use of private contractors and coordination with multiple City agencies and community partners Citywide. STM manages the work performed by the contractors, which includes pruning, removal, and planting of new trees. STM also handles tree emergency response, plan reviews for new development, redevelopment, and PWD construction projects.

The Recreation Specialty Instructor (RSI) will serve as a Street Tree Intern to assist in the data collection and inventory of street trees by recording the species, size, and location of street trees located in the City of Philadelphia. The Street Tree Intern is a field-based position.

### Responsibilities

- Under the supervision of an Arborist, collect and record data on street trees throughout the City of Philadelphia
- Use the Collector App for ArcGIS online with an iPad
- Follow established Philadelphia Parks & Recreation protocols to ensure quality, expertise and consistency of the data
- Other related duties as assigned

- Ability to read, interpret, and follow maps
