# • IS IOT (INTERNET OF THINGS) THE END OF PRIVACY AS WE KNOW IT? (2S)

People want to know what is being collected, how it is being used, and what rights they might have as data subjects. What role can layered privacy policies play? What can we learn from the NIST Privacy Framework and the FTC in managing privacy IoT risks? Is self-regulation sufficient, or is government regulation needed? Is privacy dead in a 24/7 connected world, or are reports of its death greatly exaggerated?
