# • PA CLEAN SLATE LAW AND THE FEDERAL FIRST STEP ACT (2S)

This law was passed with a near unanimous vote (188-2) and became effective on June 28, 2019. It expanded the criminal record sealing process, automatically sealing the criminal records of low-level, nonviolent offenders. Clean Slate also creates an automated computer process to seal arrests records that did not result in convictions within 60 days. Supporters hope that the law will assist Pennsylvanians in obtaining housing and jobs that were not previously available to them, as employers and landlords will no longer have access to such records.

Over 7,500 people have signed up for record-sealing under the statute. Pennsylvania is the first state in the country to pass this legislation, however, a number of additional states have since passed similar legislation. Community Legal Services will conduct a training for all attorneys in attendance regarding the record-sealing application process.
