

# **Resources for Philadelphia Immigrants**

The City of Philadelphia supports all its residents. Most city services are available to everyone regardless of citizenship or immigration status. City employees do not ask about the status of people they encounter.

### **Municipal IDs**

Municipal IDs are a form of identification that can be used by all Philadelphia residents. In order to obtain an ID, you must present proof of your identity and Philadelphia residency. When obtaining an ID, the City will not ask for immigration or citizenship status. The City will also protect Municipal ID information to the full extent of the law. The Municipal ID program will launch in Spring of 2019.

## **Education and childcare**

Children age 3 or 4 are eligible for PHL Pre-K. Learn more at <u>phlprek.org</u>. All residents have the right to attend public school from age 5 until graduation or until the end of the school year when they turn 21. Classes are available for English learners. ## Public safety

The City of Philadelphia does not conduct federal immigration enforcement. The Philadelphia Police does not ask about the immigration or citizenship status of people they encounter including victims and witnesses of crimes. ### Language Access

The Office of Immigrant Affairs manages Language Access Philly, the City's language access program that provides free interpretation services for individuals who have limited ability to read, speak, write, or understand English. ### Immigration help

Free, safe immigration help is available through one of our many partners. Beware of unlicensed immigration service providers who take advantage of their customers. Get help only from a trusted, licensed attorney or accredited representative.

### Protection from discrimination

Philadelphians have the right to be free from unlawful discrimination, retaliation, and harassment in the workplace, housing, and public places. To file an employment, property, or public accommodation violation complaint, contact the Philadelphia Commission on Human Relations (PCHR) at <u>pchr@phila.gov</u> or call the anonymous hotline at 215-686-2856.

### Health care

Low-cost emergency and non-emergency health care is available to all at public hospitals and at city health centers. Philadelphia's Division of Behavioral Health provides mental health services for adults and children requiring medical, social, and educational services. This network of services includes 11 community mental health centers, 30+ specialized behavioral health agencies, and 5 crisis response centers.
