Camp Mission

Swim for Life Camp is conducted through Philadelphia Parks & Recreation Aquatic's Office. The objectives of the Swim for Life Camp are to encourage children to participate in Department of Parks & Recreation Aquatic's programs, to provide a wholesome recreation experience in a safe and healthy environment and to teach participants sportsmanship through physical activity.

Two Camp Options (Participants may select one for Swim Camp)

Competitive Program

This option is for children who already know how to swim and can demonstrate at least two different swim strokes. Competitive program swimmers will work to refine their stroke mechanics, improve their endurance, and receive educational information on water safety. Swimmers who select this option will be given a screening test on the first day of camp.

Any child who does not pass the screening test will be placed in the instructional program.


Instructional Program

This option is for children who do not know how to swim or need to improve their skill. Children in this option will have structured and progressive lessons throughout the camp. This section will not only teach the kids how to swim, but also how to recognize, avoid, and survive dangerous situations in and around the water.

Dismissal Procedure

Only adults authorized on registration paperwork may pick up a child from camp. Additional pickup authorizations must be done in writing. Adults that pick up should have photo ID. Campers are expected to remain at the camp site until the 3PM dismissal. In the event an early departure is necessary, a letter signed by a parent/guardian is required. Phone calls will not suffice.

Any camper who leaves the site early, without permission, may be suspended or expelled.

Child Assistance Information

If your child requires the assistance of a TSS (wrap-around), you MUST note that in the space provided on the application form, along with the person's name, the agency they work for, an address and telephone number. Please inform the TSS/agency that they are required to pay for all trip admission fees. No child will be permitted on the trip without his/her TSS or a parent to chaperone. The TSS MUST stay with the child during camp hours.

Prior to the start of camp, a meeting will be held with the parent, TSS worker and Aquatics Coordinator.
