I would like to submit a statement regarding 527 W. Girard Ave for the upcoming historic preservation meeting taking place on 20 MAY 2020, 9:30 A.M.

W. Girard Ave between 5th St. and 8th St. has experienced a significant loss of historic building stock. Many prominent buildings were lost to fire, development, and demolition by neglect. This area has many empty lots, surface parking lots, and buildings that don't meet the street line. Preserving the remaining significant buildings in this area ought to be a priority.
