Why did I receive this notice? 我为何收到此通知?	Our records show that you have an Owner-Occupied Payment Agreement (OOPA) with the Department of Revenue. We recently changed our OOPA policies to make your Agreement easier for you. 我们的记 录显示您与费城税务局签订了自住房产纳税协议(OOPA)。我们最近更改了OOPA政策来为您简化该 协议。

What does this mean for you?	Your monthly payments will remain the same. 您的每月支付金额将保持不变。

If you have an installment agreement for current year tax, the Real Estate Tax liability in this Agreement will include that amount.
