COVID-19 Reopening Transition Plan

The purpose of the Philadelphia Department of Prisons (PDP) COVID-19 transition plan is to move PDP from its current shelter in place operation to a more open operation plan while continuing to mitigate the introduction into and spread of COVID-19 within its facilities. The PDP's plan takes into consideration its employees, inmate population, and overall operations.

On May 20, 2020, PDP commenced universal testing for Covid-19 of the entire May 20 inmate population and ongoing testing of subsequent new admits for COVID-19 testing. Based on the results of this universal testing, PDP entered the Phase Yellow on June 5, 2020.

The PDP will transition operations using a color-coded phased approach to allow normal activities. During these phases, PDP will follow CDC and City-recommended practices such as the use of Personal Protective Equipment, social distancing, and staggered work schedules. All staff, attorneys, and inmates are required to wear a face mask at all times. PDP's color-coded phases align with State and City guidelines and are as follows:

RED Phase – is the most restrictive and designated for new admits processed into the PDP, including having a COVID-19 test at admission and quarantined for 14 days. Any inmate presenting with or developing symptoms of Covid-19 will be placed in isolation for 14 days.

Yellow Phase – designated for inmate cohorts in the general population who are permitted outside of their cells for three hours, daily and allowed to participate in programs and services as indicated.

Green Phase - designated for inmate cohorts in the general population with a two-phased approach transitioning from larger cohorts to no cohort limitation.

The attached chart reflects color phased activities.
