DEPARTMENT OF LICENSES AND INSPECTIONS REGULATIONS UNDER PHILADELPHIA CODE SECTIONS A-901.15 and 9-102

The Department of Licenses and Inspections hereby promulgates the following regulations regarding License and Permit Fee Revisions under Sections A-901.15 and 9-102.

Fees shall be increased to an amount equal to or lesser than the fee as it existed on July 1, 2017 multiplied by the CPI Multiplier (3.5%).

New fee schedule shall take effect on July 1, 2020.
