NOTE:

Section 9-2500 of the Philadelphia Code establishes a *Registered Fire Suppression System Apprenticeship Program* as a program of apprenticeship training registered with the United States Department of Labor or a State Apprenticeship Council involving at least 8,000 hours of documented practical experience in the installation or maintenance of fire suppression systems and at least 800 hours of classroom, shop or related instruction in the fire suppression system trade.
