

How to Get Copies of Permits, Licenses, and Permit Documents

Zoning

Complete Zoning records may be accessed through <u>Atlas</u>. Searching is easy—enter the address, select the 'Licenses & Inspections' tab and scroll down to 'Zoning Permit Documents'.

Construction Permits

- Permit information from 2006 to present can be accessed through <u>Atlas</u>. Searching is easy—enter the address, select the 'Licenses & Inspections' tab.
- Copies of permits from 2006 to present may be requested by submitting the <u>Permits, Licenses, and CO Request Form</u> and required payment*.
- Copies of any plans on file may be requested by the owner or the owner's agent by submitting the <u>Building Files Request Form</u> and required payment*.
 - If you are not the property owner or the permit applicant/contractor, and are requesting copies of the plans, then you must submit a letter of authorization from the owner along with the Plan Request Form.

Note: Plans processed prior to 2004 were not retained by the Department of L&I unless associated with a Building Variance or major project.

*For copy services that require payment, review the accepted forms of payment.

Certificates of Occupancy

The existence and availability of a certificate of occupancy is based upon construction date.

- Most buildings constructed prior to 1969 or used as a single-family dwelling do not have a certificate of occupancy. Please review the <u>Code Bulletin</u> for more information.
- For 1969 2006, all certificates retained by the Department may be found in the zoning file, available on Atlas. Searching is easy—enter the address, select the 'Licenses & Inspections' tab and scroll down to 'Zoning Permit Documents'.
- For 2006 present, a duplicate certificate may be obtained by submitting the
 <u>Permits, License, and CO Request Form</u> and required payment*. The requestor is
 required to identify the associated building permit number, which may be
 searched on Atlas.

Lawful Occupancy Sign

- Any sign retained by the Department may be found in the zoning file, available on <u>Atlas</u>.
 Searching is easy—enter the address, select the 'Licenses & Inspections' tab and scroll down to 'Zoning Permit Documents'.
- <u>View the steps</u> to file for a new or replacement Lawful Occupancy Sign.

Licenses

- Current license information may be searched through <u>Atlas</u>.
- Copies of a current license may be obtained by submitting the <u>Permits, License, and CO Request Form</u> and required payment*.

*For copy services that require payment, review the accepted forms of payment.

Violations

Violation history may be searched through Atlas.

To obtain a copy of a violation, please visit the Permit and License Center** (1401 John F. Kennedy Blvd., Municipal Services Building, Public Service Concourse).
