SoLo/Germantown Civic Assoc. (RCO) opposes the hardship necessitating demolition of 113-29 Berkley St., The Moore Push Pin/Keystone Dry Plate building. As outlined by our bylaws an important part of the purpose of SoLo/Germantown Civic Assoc. (RCO) is "To preserve and enhance the historical heritage of SoLo/Germantown to maintain its unique character for future generations;"

The building at 113-29 Berkley was occupied and used for industrial purposes although most recently by Recovery King, a program for recovering addicts, many living on the premises until it was purchased by the applicant in 2018 and the residents relocated. The building then became vacant.

Dear Historic Commission,

As a longtime, 34 year-resident of the Wayne Junction area, I am writing to urge you to deny Kenn Weinstein's proposal to raze 113 Berkley Street in order to build from the ground up.

- Moore Push Pin factory is a critical historial building in our neighborhood, the launch of Wayne Junction's industrial development more than 100 years ago, and one of only a few buildings signifying that era. It is a historical landmark.
- 113 Berkley is also a unique building in architecture and design, and adds character to the Wayne Junction block.
- Weinstein is proposing replacing it with a truly ho-hum midlevel office building--ugly, and not aesthetically pleasing. There is no vision in the building plan at all. Our neighborhood, which is full of beautiful old housing, unique historical factories, and layers of history, deserves better. This would never even be an option in a neighborhood of wealth, such as Chestnut Hill.
- While I can concede that there are challenges with the infrastructure, as Weinstein argues, I believe it would be possible to retain many of the aspects of this historical building even if some new structure were incorporated around it or attached to it. It is possible to have the benefit of a beautiful, vintage facade of this building at the front, while demolishing certain parts of the building that are less stable.
- These kinds of hybrid buildings are all over Philadelphia, and are a good mix of history and current necessity. This pathway takes historical vision and commitment. I believe our neighborhood has that.
- With two lots on either side of this building, it is doubtless very tempting to raze this small structure, and go big. But we need a larger vision about what makes our neighborhood historic, distinctive, and special. As the historical commission, you are in a unique position to protect our history. No one else can do that.

Please send Developer Ken Weinstein back to the drawing board to come up with a more imaginative plan that can honors the significance of this landmark historical site.
