- A. IMMEDIATELY REPORT THE INJURY TO YOUR SUPERVISOR.
B. EMPLOYEES ELECTING CIVIL SERVICE REGULATION 32 BENEFITS MUST CONTINUE TO TREAT WITH THE DESIGNATED MEDICAL FACILITY FOR THE ZIP CODE WHERE YOU WORK.
C. FOR MEDICAL TREATMENT UNDER THE WORKERS' COMPENSATION ACT:
You must select one of the physicians or physician groups listed above. You must continue to visit one of the physicians listed above or any specialist to which that provider refers you, if you need treatment, for Ninety (90) days from the date of your first visit. This requirement is in conformance with the Pennsylvania Workers' Compensation Act, Section 306 (F) (1) (i). After Ninety (90) days, if you still need treatment, you may continue with the same physician or you may choose to go to another physician or health care provider for treatment. If you decide to go to another provider, you must notify your employer of this action within five (5) days of your visit. Your bills will be paid if your physician or health care provider reports as required (within ten days after your first visit and at least once a month as long as treatment continues). D. MEDICAL EMERGENCY:
If you are faced with a medical emergency before or after work hours, you may secure initial emergency treatment from the emergency facility listed above. However, any follow-up care to the emergency treatment must be with the designated health care provider listed number one (1) above. If you are incapacitated, you may be taken to the closest emergency facility.
E. IF YOU CHOOSE TO TREAT WITH AN OUT OF STATE PROVIDER, YOU MAY BE SUBJECT TO BALANCE BILLING.
