Dear Mr Farnham and the Historic Commision,

I ask you to support this nomination to designate the Joseph Pearson house at 5139 Wayne Ave to the Philadelphia Historic Register.

I walk past the house often and have admired it's chimney from Wayne Ave many times. The architectural detail of this house contributes significantly to the character of our neighborhood, and to this particular block of Wayne Ave, which has many 19th and early 20th century buildings intact.

Recent sales of several properties on this same block will result in renovation and preservation as single family or multifamily homes, and there are many buildings nearby in Penn Knox that are already on the register. Historic preservation has long been very important to this community, but Southwest Germantown has recently seen an unprecedented level of development interest. It's residents and business owners need your assistance in protecting its character for future generations. We welcome development that considers the community and the neighborhood, but not development at the expense of this neighborhood's contribution to the cultural and architectural heritage of the city.

I attended the January Committee meeting and I really enjoyed listening to the Committee discussion of the importance of Joseph T Pearson Sr as a Philadelphia artist and educator at PAFA, as well as the house's contribution to the social and cultural heritage of Germantown as an example of the artist's community.

It's worth noting that the Committee even voted to add Criteria C to their recommendation, on the basis that the architecture of the building reflects the built environment around it with it's contribution to a distinctive architectural style.

I hope that the Commission understands the importance of acknowledging the historical significance of the property in fulfilling the criteria for designation, and agrees with the Committee's unanimous recommendation for designation.

This will help to highlight for the record the great disservice that developers are doing to the neighborhood when they remove 19th century single family homes to maximize the volume of market rate apartments that can fill a lot size. There are many vacant properties and lots that can be developed without the removal of our existing historic houses, including quite a few owned by the city, but perhaps those do not come with the highest profit margin.

I write to you today to seek your urgent assistance in stopping the demolition of the Joseph T. Pearson house, located at 5139 Wayne Ave. in Germantown (19144).

The quality of life in Southwest Germantown is worth more than the value of its land, and as resident of 5160 Henley Street for more than 20 years and as such an adjacent neighbor of 5139 Wayne, I can without reservation and emphatically attest that the demolition of the historic Joseph Pearson House will significantly and irreparably damage the integrity of my community and compromise the value and quality of life for my neighbors and myself.

I understand that the property was purchased in March of this year and almost immediately listed for resale as a construction-ready parcel, approved for more than 40 apartment units. In addition to disfiguring the charm of the neighborhood through the removal of one of its most elegant facades, this change will negatively alter the walkability of Wayne Avenue and add congestion to Henley Street, which it cannot sustain.

The Pearson home itself has graced our neighborhood for well over a century, and while it does require rehabilitation to return to use, it is in no way dangerous or otherwise unwelcome. The architectural detail of the home represents a level of craftsmanship unique to the past, informing and inspiring all who look upon them. With repair, the Pearson home could support one or more families within its current zoning and continue to contribute to this picturesque, low- to moderate-income residential neighborhood and business corridor, which its current owners (investors) have likely never visited. Removing a physical testament to the rich history and cultural heritage of Germantown serves no one. Once these homes are gone, they cannot be replaced, and children and adults in Southwest Germantown deserve to walk in the steps of history and to look upon its face every bit as much as children and adults in any other neighborhood in this city.

On a personal level, my own home life in Germantown cannot be separated from the Joseph T. Pearson, which like his great painting, has always existed "Over The Hedge." The Pearson House helps tell the story of my life and my community, existing across different periods of time, encompassing many different generations of people, and demonstrating a rich history and resilience in the face of substantial change. The Pearson House is an integral part of the built environment along Wayne Avenue, providing spatial and aesthetic balance to the denser row and twin homes on Henley Street and acting as part of Germantown's proud architectural legacy, shared by all regardless of race, income, or social status. Living alongside the historic structures of Southwest Germantown has provided me with a pride of place and a feeling of ownership in the community and its long history, and preservation of the Pearson House will contribute to stabilizing our close and connected neighborhood, which is working through years of disinvestment and into a shining new future. Removal of this building will slow revitalization of the Wayne Avenue business district by breaking up the streetscape and making the area less likely to support the desirable businesses that will improve life for area residents.

The parcel is over 12,000 square feet, and the house footprint is approximately 3000 sf. With basements and three stories, that would equal 36,000 sf available for new housing, while preserving the existing historic property for adaptive residential reuse. I write to express my strong support for the designation of the Joseph T. Pearson House, 5139 Wayne Avenue, as a historic property.

In that house, Pearson came of age and studied at PAFA, and while living there he developed a distinctive style honoring the aesthetics of Japanese art, making him a strong contributor to early 20th century innovations in American art.

Germantown has been a community of artists throughout the 19th and 20th century, and many important figures lived here. Characterized by relatively spacious and attractive housing, green spaces and former industrial buildings converted to studios, Germantown continues to be a community of artists. I have walked its streets with my partner, a portrait painter, as he points out the homes and former homes of well-known artists. He has also pointed out, again and again, an empty lot where the former home of a well-known artist fell into ruin and was simply knocked down, fruit of ignorance and uncaring. Not only were these landmarks in the history of American art, they were also once lovely homes.

At this time, the value of Germantown homes is skyrocketing. This can lead either to preservation or to destruction. The actions taken by the Philadelphia Historical Commission are essential at this time to preserve the character and quality of life in Germantown, and in other Philadelphia neighborhoods.

We who carry forward the traditions of art, music, scholarship and responsible custody of our homes and neighborhoods must advocate for and carefully observe the designations that should become the basis for historic preservation and the effectiveness of public policy in making them real.

Dear Dr. Farnham,

I write on behalf of Historic Germantown, a partnership of eighteen historic houses, sites, and museums in Northwest Philadelphia – "the German Township" – that have come together into one organization to protect, preserve, and share some of Philadelphia's prized historical assets. At the regular December meeting of the Board of Directors of Historic Germantown, the Board voted to support the nomination of the Joseph T. Thurman, Jr., House at 5139 Wayne Avenue in Germantown for inclusion on the Philadelphia Register of Historic Places. The Board agrees with the twin merits of the Pearson House as set forth by the Keeping Society of Philadelphia in its nomination: a) this historic resource is associated with the life of a person significant in the past; and b) this historic resource exemplifies the cultural, economic, and historical heritage of the early twentieth-century community of Germantown.

Joseph Thurman Pearson, Jr. (1876 – 1951) was born and raised in Germantown and 5139 Wayne Avenue was his childhood home. His father was typical of the new men who made Germantown their home in the years after the Civil War, those fortunate men who – for the most part – learned a trade well, established small businesses of their own, and built them up until they provided real prosperity and often, financial independence. Joseph T. Pearson, Sr. (1850 – 1920) was such a man. The older Pearson placed his son in the architectural firm of Wilson Eyre, but Eyre soon recognized the young man's extraordinary talent as a painter. The younger Pearson turned to the Pennsylvania Academy of Fine Arts (PAFA) in Philadelphia and was educated there. He then traveled to Europe, where he devoted an entire year to meeting with and studying the work of a number of the most distinguished European artists of that era.

Joseph T. Pearson, Jr. returned to the United States in 1902 and married. By this time the Pearson family had moved to a far grander house in Germantown, but still owned the house and property at 5139 Wayne Avenue. The newlywed couple happily made their home there and Pearson entered into the most productive phase of his long career. As the opportunities arose,

he submitted his paintings – primarily landscapes and portraiture – to different exhibitions and they began to win commendations and prizes. Pearson's career flourished. In September 1909, the Philadelphia newspapers reported that PAFA had "added [Pearson] to the teaching corps," where he would start as an "assistant instructor in drawing and painting." This was the beginning of a life-long teaching career at PAFA, one that extended to 1937.

These were also the years in which Pearson received repeated honors from his colleagues and peers in the world of fine art. In the decade between 1908 and 1918, he won a total of four prizes from PAFA, two prizes from the National Academy of Design, and one from the Panama-Pacific International Exposition. A few years later, in 1926, he won the Gold Medal at the U.S. Sesqui-Centennial Exposition, which was held in Philadelphia.

This three-paragraph sketch of Pearson's first forty-two years is an important part of Historic Germantown's advocacy for the nomination. As the Pearson House in Germantown is considered for inclusion on the Philadelphia Register of Historic Places, *it is important to note* that the most celebrated work of Pearson's long career was sketched and painted at his home on Wayne Avenue.

In 1918, Pearson purchased from a very wealthy Philadelphian, William West Frazier, an old farm house and barn with nine acres of land at the intersection of Huntingdon Road and Creek Road, directly on the banks of Pennypack Creek, in what was then Upper Moreland Township, in Montgomery County, about ten miles north / northeast of Germantown (this land may now be within the bounds of the Borough of Bryn Athyn or of Lower Moreland Township; maps are unclear on this point). In 1921, Pearson purchased an additional twenty-two acres of adjoining land. He lived in this bucolic place for the remaining thirty years of his life.

Historic Germantown represents a long tradition – a tradition now more than 120 years old – of valuing historic preservation in northwest Philadelphia ("the German Township"). It is with that vision, purpose, and practical experience in mind, that Historic Germantown recommends the inclusion of the house and lot at 5139 Wayne Avenue for inclusion on the Philadelphia Register of Historic Places.
