## Chair called the meeting to order at 6:01 PM

## **REGULAR SESSION**

- 1. <u>Chair's Report</u> Ronda Goldfein welcomed everyone to the zoom meeting. PAC is waiting for the CPOC transition.
- Executive Director's Report –Anthony Erace presented the Executive Director's report. First, he wished Angelica Hendricks well, and thanked her for her services. Anthony reported on the receipt of 11 complaints last month, (50 YTD), and looks forward to expanding services to Philadelphians following the implementation of CPOC.
- 3. <u>Presentation Lt. Norm Davenport reported on "The Life of an Investigation" in the</u> Homicide Unit:
  - 1) Homicide occurs within the city limits. Typically, incident is reported via 911 but can also be reported by M.E., eyewitnessed by an officer, or instituted following the death of a victim (who did not die immediately).
  - 2) Scene is secured; injured persons cared for.
  - 3) Witnesses are identified, evidence is located, marked and secured. Camera locations noted.
  - 4) Notifications to Police Radio triggering detective response; scene survey, witnesses interviewed, video recovery, photos, evidence recovery, etc.
  - 5) Review video footage and proceed based on activity observed.
  - 6) At Headquarters: interviews, video play, extract data via cell phone analysis, search warrant preparation; Google location history.
  - 7) Data is mapped using My Google Maps.
  - 8) GPS Ping (Subscriber can send signal, requiring return signal, to pinpoint location).
  - 9) Video media release, information release, arrest warrants.
  - 10) Video editing transforms raw video into "crime commercial".
  - 11) Disseminate video: electronic rollcall, social and traditional media.
  - 12) Case preparation; assemble and compile evidence for presentation and use.
  - 13) Case review (Homicide Supervisor, DA's Office, Magistrate (warrants), Judge (Preliminary Hearing).

- 14) Prepare Court presentation.
- 4. <u>Public Comment</u> Questions for Lt. Davenport included concerning digitalization of evidence, transportation of shooting victims during COVID, light/camera combinations, citizens' registration of household cameras, the presence of public cameras, and the increased violence and shootings in the city.
