To the Philadelphia Historical Commission:

I support designating the properties at 311 North 19th Street and 312 North 18th street in ZIP code 19103, the John W. Hallahan Catholic Girls' High School building and its annex known as the Cathedral building, as historic.

The building is the vision of Mary McMichan who provided its construction funds. It was the first tuition-free and purpose-built high school for the education of Catholic women in the United States, and the mother school for other girls' schools that followed in later years, such as St. Hubert's, West Catholic, and Little Flower. It predates the Nineteenth Amendment, which guaranteed women's right to vote nationwide, by nine years.

The buildings continued to serve their role to educate women of immigrant families and at-risk neighborhoods (Kensington, Northern Liberties, West Philadelphia and Roxborough) until forced to close in June 2021. By daily interactions in these buildings, this diverse community of women, now some 40,000 strong, learned tolerance, understanding and compassion towards others, starting half a century before Martin Luther King and the civil rights movement and, I reiterate, before women's nationwide right to vote.

Walt Disney was so taken by the school's mission that he agreed to let the school use his newly created character Mickey Mouse as their mascot.

Architecturally, the building's exterior upper cornice and frieze is adorned with the names of significant women in history. It is the only known building in Philadelphia to have had its cornerstone blessed by a pope, Pius X, and it contains the relics of seven saints. Major portions of the interior were designed to be lit by natural light, with transom and clerestory windows allowing sunlight into the corridors

But most significant to the modern world is that Hallahan taught young women advanced mathematics, challenging the assumption that a woman's role would be a housewife. The math department in the Cathedral building inspired a young Irish immigrant named Kathy "Kay" McNulty (Antonelli) to become one of the first computer programmers in the world. She and five female colleagues programmed the groundbreaking computer ENIAC at the University of Pennsylvania for the Department of Defense. McNulty, relatively unknown in the USA, is celebrated in Ireland as the "Mother of Computer Programming" with the Irish government's supercomputer bearing her name.

Think of this every time you use your computer or smartphone from now on: it started at J. W. Hallahan Catholic Girls' High School.

I encourage the commission to designate these buildings as historic, as they housed an institution that educated women in many fields of study, even before they had the right to vote.

So please designate the buildings as historic.

I fully support the combined historical designation of both the Hallahan and Cathedral buildings, 319 N 19th St and 312 N.18th St respectively. There is no debating the historical early 20th century architecture, of both buildings. The rich history of Hallahan is still significant today, as it was from its 1911 beginning as the first all girls' catholic high school in the country.

By its own account, the Historical Society named John W. Hallahan Catholic Girls' High School as "the keystone for high school education for Catholic education". Hallahan's visionary founder, Mary Hallahan McMichan, fought for equality for women. In many ways, women are still fighting for equality today, particularly in earning the same pay as our equally educated male counterparts.

The US Treasury awarded the students of Hallahan a Certificate of Merit, for selling enough bonds to purchase 132 jeeps for the Army. Based on the picture in the Special Collections Research Center on Temple University Libraries, it's clearly during World War II.

In 2011, Director Neil Burger filmed Hallahan as the police station in his movie, Limitless (starring Bradley Cooper). Clearly the historical architecture played a role in his choice.

Although these are only a few examples, Hallahan legacy has been interwoven in not only Philadelphia's history, but also the United States of America's history.


