The collections adjustment adjusts the unit cost for anticipated receipts based on customer payment patterns to recognize that a portion of the fiscal year billings are not collected within that fiscal year. The collections adjustment does not include collection efforts nor personnel time associated with the pursuit of outstanding customer bills.
