Workforce and Career Pathways Information Sheet Law Notice to Employees

Chapter 9-5500

Provide Information on Jobless Benefits and Job Training Resources

Employer requirements:

Notify employees that they are entitled to the Workforce and Career Pathways Information Sheet upon separation from employment. The notice required must be in English and in any language that is the first language spoken by at least five percent (5%) of the workforce.

Provide the Workforce and Career Pathways Information Sheet to eligible employees upon separation from employment.

If the employer initiates the separation, the employer must provide the Workforce and Career Pathways Information Sheet to the employee at the time of notice of separation.

If the employee initiates the separation, the employer must provide the Workforce and Career Pathways Information Sheet 30 days after the employee's notification of separation or actual separation from employment in all other cases, whichever is earlier.

Any hiring entity, including any agency or person acting directly or indirectly in the interest of the hiring entity, who is in violation of Section 9-5503 shall be subject to a civil penalty not to exceed \$300 for each offense.

This notice will serve as the Workforce and Career Pathways Information Sheet which includes information from Philadelphia Works on jobless benefits, career and technical skills training, educational opportunities, and other related information.
