



How to Amend a Trade License in eCLIPSE

Step 1: Sign in to eCLIPSE

- 1.1 Go to https://eclipse.phila.gov
- 1.2 Enter your registered email address and password
- 1.3 Click 'Sign In'

- **3.4** Click the **"Submit**" button to submit the amendment request.
