You do not need a username and password to file a Wage Tax petition on the Tax Center, simply select "Request a Wage Tax refund" from the front page. Although paper forms are available, we encourage you to file through the Tax Center to avoid delays.

Instructions

If you are approved for Pennsylvania <u>tax forgiveness</u> (PA 40 Schedule SP), you may also be entitled to receive a refund of City Wage Tax withheld by your employer.

You are **not eligible** for a refund if you owe delinquent taxes or fees to the City of Philadelphia. You **must use a different petition** to request a Wage Tax refund:

- if you are not a resident of Philadelphia,
- for work performed outside Philadelphia, or
- for non-reimbursed business expenses.

The checklist below includes a list of documents **you must submit** with your application.

Ocument Check List

With your form, you must submit your:

- Completed Pennsylvania 40 Schedule SP for tax year 2021.
 - The City of Philadelphia will check to make sure these documents match your state records.
- W-2 forms for which you are requesting a refund, showing Federal, State, Medicare and Local wages and withholdings.
 - If you have more than four employers, please complete additional petition forms and attach it to this application.
 - Remember, do **not** include your spouse's W-2 information. Your spouse must file their own income-based Wage Tax refund petition to receive a refund.

Total eligibility income

Your **total eligibility income** must be below the limits set by the Pennsylvania <u>tax forgiveness</u> program (40 Schedule SP). The full 2021 eligibility income table is located on the Pennsylvania Department of Revenue's website: <u>www.revenue.pa.gov</u>.
