The motion to approve carried 8-0 unanimously on a roll call vote.

APPLICATIONS FOR SERVICE-CONNECTED DISABILITY BENEFITS

Case of Lee M. Ellingsworth, Application for Service-Connected Disability Benefits under Pension Plan "B"

This is an application submitted by Lee Ellingsworth, former Police Officer for Service-Connected Disability benefits under Pension Plan "B".

According to Mr. Ellingsworth on June 23, 2017, he responded to a "man with weapon" call and located the suspect in the basement of the home. The suspect became combative and resisted attempts to place him in custody. Mr. Ellingsworth states that during the struggle to place handcuffs on the suspect he injured his right hand, knuckle, and middle finger.

The motion to approve carried 8-0 unanimously on a roll call vote.

<u>Case of Donna Sherwood, Application for Service-Connected Disability Benefits under</u> Pension Plan "B"

This is an application submitted by Donna Sherwood, former Police Officer for Service-Connected Disability benefits under Pension Plan "B".

According to Ms. Sherwood on September 18, 2019, while attempting to restrain an unruly and combative male prisoner she was struck on the left side of her chest. Ms. Sherwood reports that she sustained injuries to her left shoulder, left arm, and upper chest area (left).

Case of Joseph Wilson, Application for Service-Connected Disability Benefits under Pension Plan "D"

This is an application submitted by Joseph Wilson, former Police Sergeant for Service-Connected Disability benefits under Pension Plan "D".

According to Mr. Wilson on October 19, 2017, while on duty he was assaulted by a "man high on drugs". The suspect kicked him on the left side several times striking his hand, forearm, shoulder, back, and neck.

The motion to approve carried 8-0 unanimously on a roll call vote

Case of Carlton V. Lane, Application for Service-Connected Disability Benefits under Pension Plan "J"

This is an **administrative** application submitted by Carlton Lane, former Correctional Officer with the Department of Corrections for Service-Connected Disability benefits under Pension Plan "J".

According to Mr. Lane, on January 11, 2019, while fighting with an unruly hostile inmate, he fell and struck his left shoulder on the ground.

The Board voted as follows:

The motion to approve failed 0-8. Motion denied.

Case of Rodney Wilson, Application for Service-Connected Disability Benefits under Pension Plan "Y"

This is an application submitted by Rodney Wilson, former Laborer with the Streets Department for Service-Connected Disability benefits under Pension Plan "Y".

According to Mr. Wilson, on February 27, 2017, while exiting his work truck he fell to the ground striking his left side, knee, hand, and breaking his left wrist.

The motion to approve carried 8-0 unanimously on a roll call vote.

Case of Jeffrey L. Ison, Application for Service-Connected Disability Benefits under Pension Plan "Y"

This is an application submitted by Jeffrey Ison, former Interceptor Services Worker I with the Water Department for Service-Connected Disability benefits under Pension Plan "Y".

According to Mr. Ison on November 5, 2020, while unloading a water pump from his work truck he injured his lower back. Mr. Ison reports that he was unable to stand or walk without pain.

The Board voted as follows:

The motion to approve failed 0-4-4. Motion denied.

Case of Thomas Tracy, Application for Service-Connected Disability Benefits under Pension Plan "B"

This is an application submitted by Thomas Tracy, former Police Officer for Service-Connected Disability benefits under Pension Plan "B".

According to Mr. Tracy on February 24, 2018, while subduing a combative and resistant suspect a struggle ensued. Mr. Tracy states that during the struggle he was punched in the face and his left shoulder was injured when the suspect pulled away.

The motion to approve carried 8-0 unanimously on a roll call vote.

Case of Kevin D. Bernard, Application for Service-Connected Disability Benefits under Pension Plan B

This is an application submitted by Kevin Bernard, former Police Sergeant for Service-Connected Disability benefits under Pension Plan B.

According to Mr. Bernard on November 11, 2010, while conducting a vehicle stop and subsequent search the vehicle passengers were removed. A male passenger was identified as "man with a gun" and a struggle ensued. Mr. Bernard reports that during the clash he twisted and injured his left knee.

The Board voted as follows:

The motion to approve carried 5-3

Case of Larry O. Burnett, Application for Service-Connected Disability Benefits under Pension Plan "Y"

This is an application submitted by Larry Burnett, former Correctional Officer with the Department of Corrections for Service-Connected Disability benefits under Plan "Y".

According to Mr. Burnett on July 12, 2020, while restraining a resistant inmate his right hand/wrist was injured. Mr. Burnett states that during the struggle they both fell to the floor landing on his extended right hand/wrist.

The motion to approve carried 8-0 unanimously on a roll call vote.
