Dear Commissioner Bettigole and Mr. Decker:

We are counsel to Ivy Hill Post Acute Nursing & Rehabilitation LLC ("Entering Operator") and are writing to provide notice of the intended acquisition of the facility located at 1401 Ivy Hill Road, Philadelphia, Pennsylvania 19150 (the "Facility"). This Notice is being sent on behalf of Entering Operator, 1401 Ivy Hill, LLC ("Entering Property Owner"), and Embassy Ivy Hill, LLC ("Exiting Property Owner and Operator"), as joint notice of the sale pursuant to City of Philadelphia Ordinance § 6-409, as revised June 9, 2021 (the "Ordinance") of their intent to transfer ownership of the real estate and operations of this long-term care facility, effective November 1, 2022.

 - B. <u>Entering Property Owner.</u> Entering Property Owner is a Pennsylvania limited liability company whose sole member is 1401 Ivy Hill 2 LLC, another Pennsylvania limited liability company.
