Conditions



- License holders must attach a City issued Radio Frequency Identification (RFID) medallion to each dumpster.
- License holders must immediately report any changes of their license information to the Department by calling 311.
- All exterior property and premises, and the interior of every structure, shall be free from any accumulation of rubbish or garbage.
- Every occupant of a structure shall dispose of all rubbish in a clean and sanitary manner by placing such rubbish in approved containers and shall also dispose of all recyclable materials.
- The owner of every occupied premises shall supply approved covered containers for rubbish, and a separate, approved container for recyclable materials.
- All dumpsters shall:
 - Be kept in good repair, free of offensive odors, and clean;
 - Be constructed of fire resistive metal.
 - Have a lid which is securely attached to the body of the dumpster and that when closed forms a secure seal;
 - Have no holes in the bottom except for a drainage hole, which shall be equipped with a secure plug;
 - If painted, have paint that is kept in good condition;
 - Be kept free of graffiti.
- All dumpsters shall be cleaned and sanitized at least once every six months, or more often if either the Department or the Public Health, Fire, Police, or Streets Department orders.
- No dumpster shall be serviced between the hours of 9:00 pm and 7:00 am.
- The absence of a medallion on a dumpster, or significant damage to a medallion suggesting the medallion is inoperable, shall be reported to the Department of Streets.
