Focusing primarily on PPR's PlayStreets and PlayParks initiative, this position will drive the PlayMobile to various PlayStreets and PlayParks locations and will instruct and organize playful learning recreation activities as well as plan and schedule literacy enhanced recreation activities. Additional locations, such as the Ben Franklin Parkway and Recreation Centers may also utilize PlayMobile services to support summer camps and other events.

The successful candidate will be able to work outside in varied weather conditions and will possess a valid driver's license with a clean driving record.

Essential Functions

- Drive the PlayMobile and set-up play tools and landscapes on PlayStreets and PlayParks, at Recreation Centers and in open spaces (e.g., McPherson Square, Harrogate Park, and select PPR parks).
- Initiates collaborative play with children as well as parents/caregivers.
- Attend literacy and playful learning training from the Free Library of Philadelphia and Fab Youth Philly with Temple Infant Child Labs
- Initiates play for groups of varying age levels, backgrounds, and interests; assists in the preparation of
 publicity for scheduled events.
- Prepares records and reports on attendance, attitude, and progress of recreation activities.
- Supports implementing literacy survey tool with children.
- Performs related work as required.
