PUBLIC ADVOCATE OUTREACH REPORT

Via Community Legal Services social media and direct outreach, the Public Advocate provided widespread notice of opportunities for Public Input in this Rate Proceeding, as follows:

- Facebook posts on March 10, March 15, March 18, March 21 (Spanish).
 - o Boosted ad garnered 4,274 link clicks and 124,330 impressions
- Twitter post on March 10th had 9,464 impressions, 133 engagements, and 24 retweets.
- Instagram posts on March 10, March 15, March 18, March 21 (Spanish)
- Additional posts and shares by numerous elected officials.

- Creation and direct distribution of the attached flyer in English and Spanish (see attached spreadsheets). Note that outreach to elected officials was limited to information sharing, as the Public Advocate's contract prohibits lobbying.
- In addition to our outreach, we received direct emails and calls from 18 individuals, and provided support and facilitation for them to provide public input.
