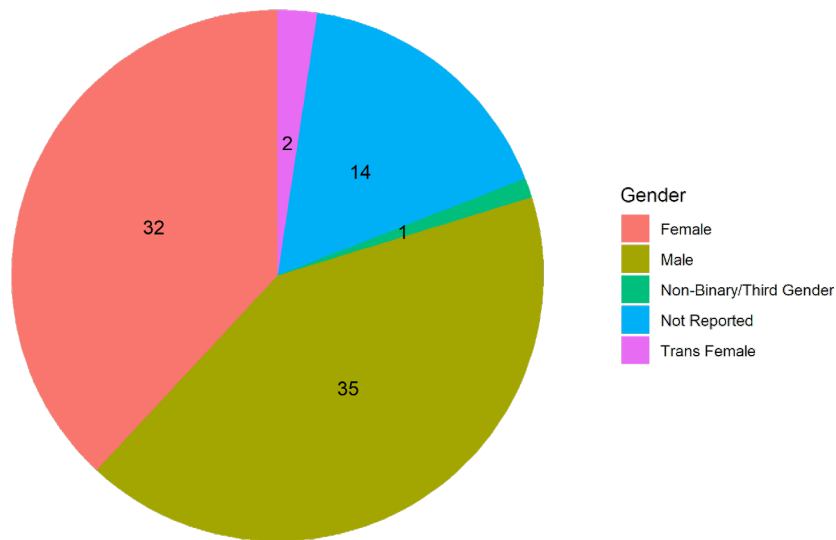

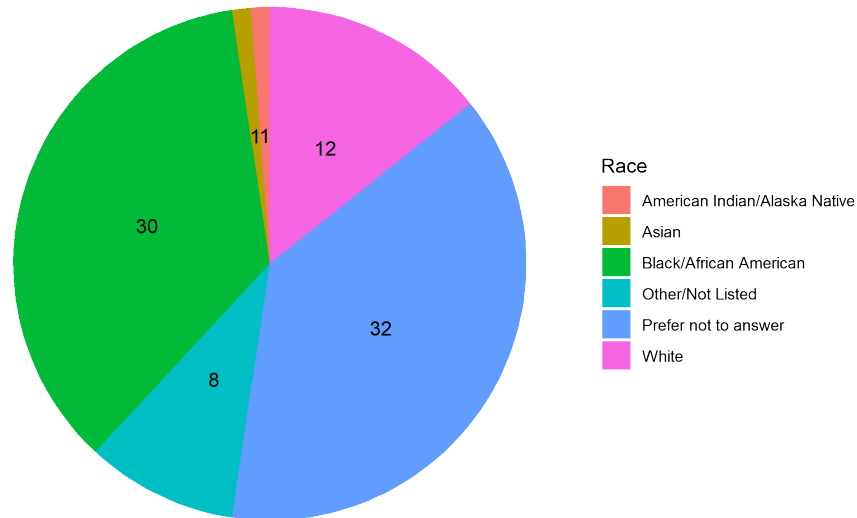
Complaint Data

88 complaints have been referred to internal affairs by CPOC this calendar year. To date, 13 complaints were referred in the month of June. The complaint data presented is the cumulative breakdown of complaints referred to IAD in the calendar year 2023.

Gender Breakdown

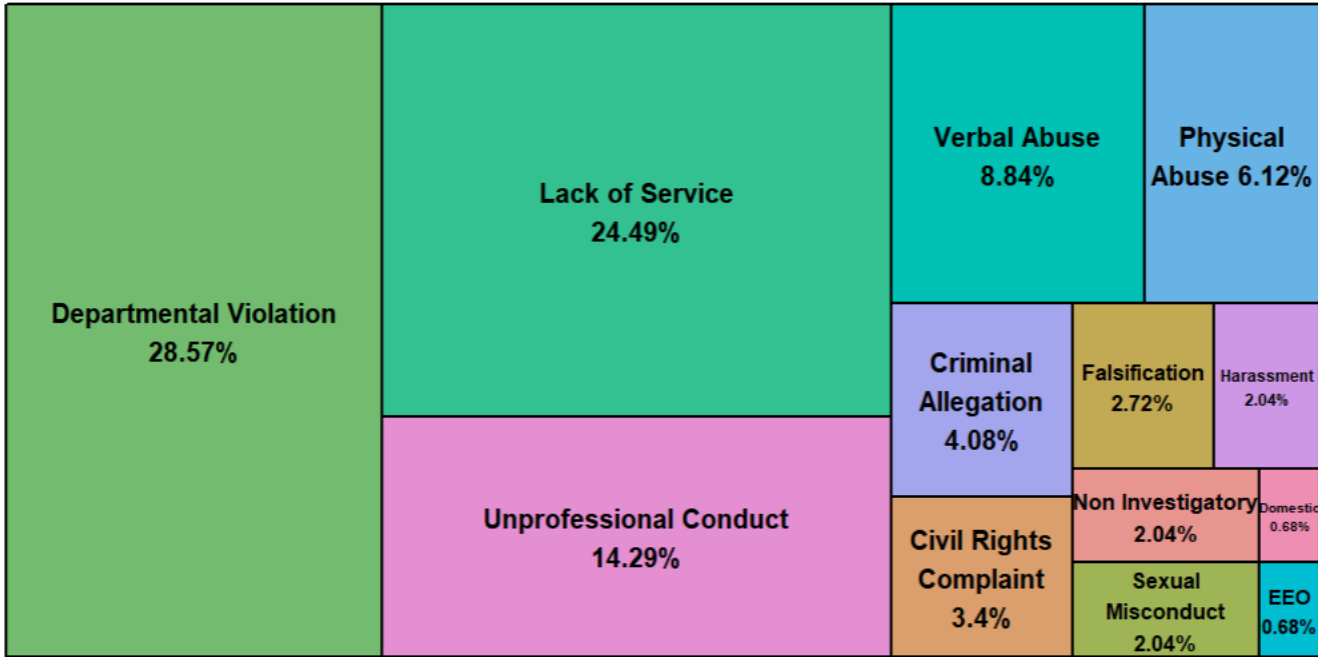


Race Breakdown



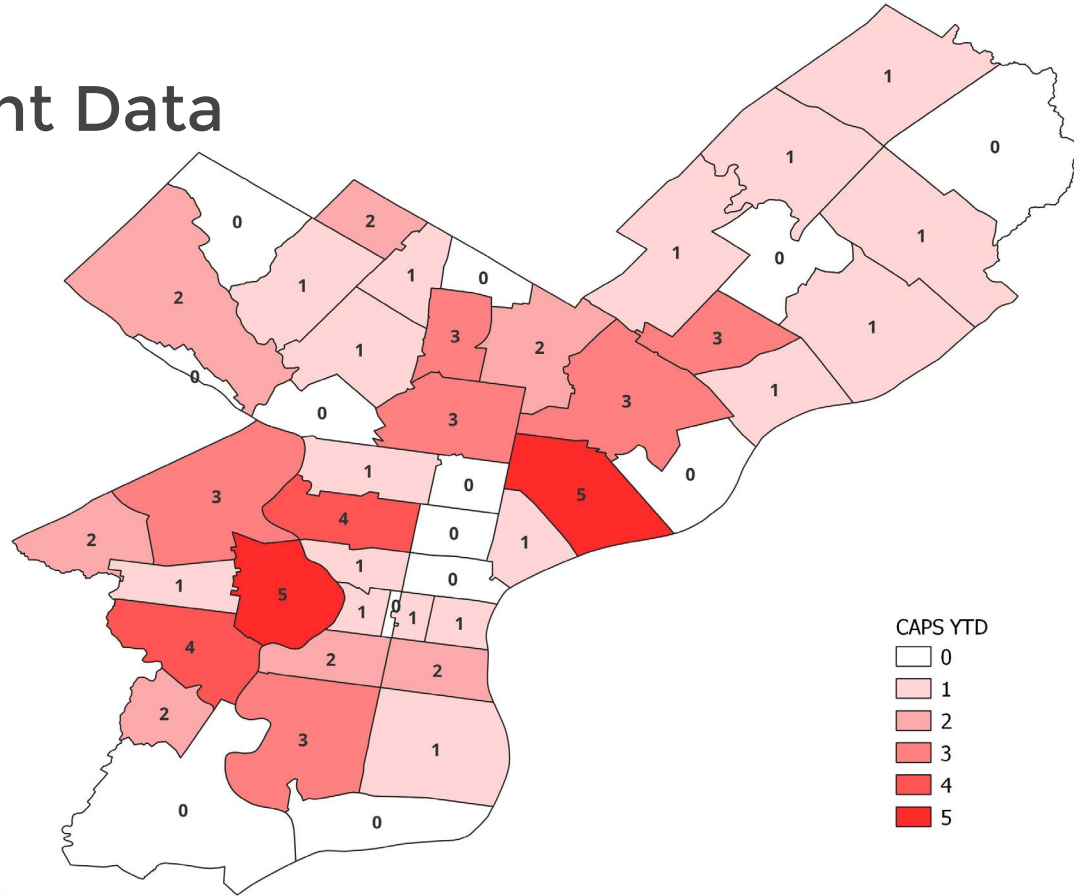
Complaint Data

Of the 88 complaints CPOC has referred in calendar year 2023 these are the percent of misconduct allegations. 28.57% of complaint allegations were Departmental Violations. It should be noted a single complaint can have multiple misconduct allegations.

Auditing & Monitoring Unit

Auditing Sampling


- Pulling 100% of cases with serious allegations (i.e. sexual assault, constitutional violations, etc.)
- Then pulling a random sample across the remaining population of cases.
- We will explore the breakdown between:
 - **Districts**
 - **Allegations**

This sampling strategy should allow us to make generalizations about these cases without overworking the small team of auditors.

Investigation Unit

- Completed an Inquiry into a fatal incident involving PPD from 2022 and submitted a criminal referral to DAO and PPD for further review.
 - Assisted in the onboarding of our new General Counsel Catherine Twigg, introduced her to the Officer Involved Shooting team supervisor Lt. Hendershot.
 - Ongoing oversight of PPD response to the Kingsessing mass shooting July 2-3, 2023. CPOC has met with PPD leadership to discuss and review evidence, including police responding to the wrong location on July 2, 2023. This incident is still under investigation by PPD's Internal Affairs Division and CPOC will continue to monitor this investigation and provide updates and/or policy recommendations, as appropriate.

Officer Involved Shootings since March 6, 2023

PPD defines an officer involved shooting (OIS) as “the discharge of a firearm, whether accidental or intentional, by a police officer, whether on or off duty [at a person].”


Note: There were 3 officer-involved shootings in February and March 2023, prior to CPOC’s Director of Investigations starting oversight.

Since March 6, 2023, there have been 6 Officer Involved shootings.

In the following cases, PPD’s OISI (Officer Involved Shooting Incident Unit) recommended no criminal charges to District Attorney’s Office (DAO). Unless otherwise indicated, these cases are still under consideration by the DAO.

- March 24, 2023: 1500 block of East Johnson Street
- April 17, 2023: 20th and Chew Streets (DAO has cleared the officers in this case)
- April 29, 2023: 400 block of W. Bringhurst Street
- May 4, 2023: 2300 block of Fawn Street
- May 31, 2023: 2800 block of Ruth Street
- June 8, 2023: 7600 block of Ridge Avenue


In each case, CPOC will continue to monitor PPD’s administrative investigations and may issue opinions and/or policy recommendations, as needed.

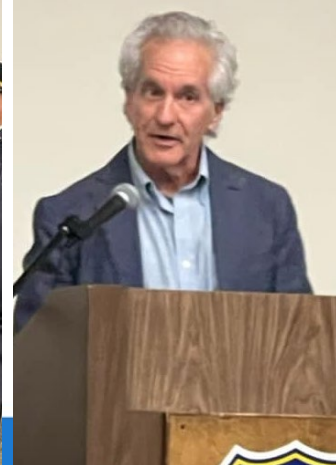
