This administrative item proposes several new bus shelters submitted by the Office of Transportation, Infrastructure, and Sustainability, also known as OTIS. These shelters are part of their ongoing shelter improvement program for the city. The Commission has reviewed a series of these over the last year or so.

This proposal is for three new bus shelters at various locations around the city. All the locations are proposing new shelters, where currently no shelter exists.

Staff has reviewed each location in terms of complete street standards. Additionally, the Streets Department will also review these locations for compliance. Staff recommends approval for the shelters as they offer improved conditions for transit riders.
