If you were unable to pre-register, during the public comment period please use the "raise hand" feature in Zoom. If you are joining by phone, you may also use the "raise hand" feature by dialing "*9" during the public comment period. Each speaker has two (2) minutes for comment.

The public can also submit comments in writing before the meeting. Comments submitted in advance should not be read during the live meeting. Committee members will consider written comment and spoken comment equally. Written comments will be incorporated into the official meeting minutes. Written comments can be submitted by emailing CDR@phila.gov

The deadline to submit comments is noon on Thursday, December 14, 2023.
