Commissioner Almiñana wanted to know what type of membrane will be applied to the roof, specifically, if it will be a high reflective membrane. A representative of DPP responded and provided an overview of the material being used is a 3-ply SBS modified bituminous roof, with white cap sheet.

Towey Playground 1832 N Howard Street

Review Type: Minor construction project on City property

Project Details: Playground replacement and exterior site improvements

Applicant: Philadelphia Parks and Recreation (PPR)

This administrative item proposes the replacement of certain elements within Towey Playground at 1832 N Howard Street.

The scope of work includes the installation of new safety surface, play equipment, replacement of benches and asphalt work, and a new trash enclosure adjacent to Howard Street. Two trees are being removed as part of the scope of work.

Commissioner Almiñana asked if any trees were going to be replanted if they are removing two large trees. Almiñana noted there will be a net loss of biomass, and it lessens the shade canopy in the area. A representative from PPR explained that since it was a small area no additional trees will be planted in the space. She also stated that the community would have liked to have all trees removed due to the maintenance of leaf litter and other trash.

Public Questions: Timothy wanted to reiterate concerns about the non-replacement of trees. Given that the city created a tree plan to further build out an urban tree canopy, it was recommended that new trees be incorporated into the work.

Commissioner Lowe asked if the maintenance plan for the site is the same or will there be a new proposed plan? PPR responded that the maintenance of trees and playground will remain as is with PPR.

Chairperson Roesch asked for a motion to approve with a request for a new tree to be planted as part of the proposal.

Upon the motion made by Commissioner Almiñana and seconded by Commissioner McEneaney.

restroom instead of the other Portland Loo options previously noted, as PPR would be able to maintain the restroom. Chairperson Roesch then asked for questions or comments from the Commission or Public.

Commissioner Almiñana asked about how EMT, and maintenance vehicles access the site, given that the area has a serious short dumping issue. Sarah answered that Gratz Street has two removable bollards that allow for access as needed.

Chairperson Roesch asked how many trees are being put in the park. Sarah answered 24 -25 trees are being added.

Chairperson Roesch asked what material along the walkway was being used for the proposed signage saying, "Friends Select School." The answer was wood and steel.

Commissioner McEneaney asked will the play area be accessible to the public? The answer was no, but talks have been held about possibly opening it up to the public.

Commissioner Osorio asked if the space becomes public, has lighting been considered? And if not, would the area be gated? The answer was yes, there would be gates; however, the gate has not been fully designed yet so it was not included in the renderings.

Commissioner Lowe had a technical question about getting rid of the 24 parking spaces in and how it would impact their zoning requirements. The answer was that they are prioritizing kids playing over the parking spaces and have noted that teachers are asked to park off site. It was noted that the zoning requirements should not be impacted at this location.
