Position Summary

Fairmount Park is home to four historic houses which are open to the public as house museums. The homes served as the rural summer villas of wealthy families during the eighteenth and early nineteenth century. They are considered among the most significant examples of early-American architecture and their styles, furnishings, history, and stories illustrate the culture and domestic lives of the time.

The Recreation Specialty Instructor (RSI) will lead tours at Lemon Hill Mansion or Laurel Hill Mansion. Guides communicate carefully researched historical information to help the public connect with each site's rich history. Tours include information on 18th and early 19th-century architecture, lifestyles, and the occupants of the houses. The guide will be responsible for working from 10 a.m. to 4 p.m. every Thursday to Sunday from hire date until late December, 2024. Training is provided.

Other job responsibilities include ensuring facility is ready for visitors, assist with social media postings/marketing, assisting with special public programs, writing short blog posts, coordinating with onsite staff/caretakers and light administrative duties. This position reports to the Planning Preservation and Development Administrator.
