RESPONSE:

The following responses apply to the 26,566 customers who were TAP participants in March 2024 and were enrolled in TAP through the IDEA prequalification process. Other IDEA pre-qualified customers enrolled in March but who did not receive a TAP bill in March are not captured in these figures, nor are customers who were enrolled through another means (LIHWAP prequalification or a traditional application) at any point in time, regardless of whether they received a TAP bill in March 2024. Information cannot be provided at a customer level, so totals and averages are provided throughout. Note that since the number of IDEA-prequalified TAP participants in March was larger than the number in February, the average values shown below for April 2023 through February 2024 may not be the same as those reported in PA-TAP-1-10.
