#### 1. 44-24 Pure Green 1124 Walnut Street

Alex Smith provided an introduction of the project before passing it over to Sharon Brandt and Tiara Council, who presented (00:05:04).

Ms. Council and Ms. Brandt and members of the Commission discussed the design, structure, projection, recessed lighting, storefront window, and blade signs followed by Chairperson Roesch suggesting exploration of a more creative design, along with Commissioner Almiñana recommending a resubmission before the Sign Committee, which would be a continuance (00:08:52 - 00:23:20). Additional comments from the Commission were made about business's proposed sign and the regulations as it relates to the project (00:24:41 – 00:31:59).

Commissioner Almiñana inquired about a fence being placed around the bioretention basin, the proposed drainage plan and course equipment. Mr. Conlon and Chris Stigler addressed the inquiries and provided information about the drainage system.

Based on comments from the Commission, Chairperson Roesch expressed several concerns and questions regarding proposed tree plantings, how drainage will be handled, how chemicals and fertilizers are being addressed and the stormwater management of the site, making sure that the functions of these maintenance buildings do not impact adjacent waterways. Commissioner Almiñana added comments about nearby steep slopes, mowing, and asked about the course equipment (01:34:52).

Seeing no further questions or comments from the Commission, Mr. Smith reiterated Chairperson Roesch's request for a motion from the Commission (01:36:22).

Commissioner Lowe wanted to know about building elevations, and the proposed mechanical equipment on the roof. Commissioner Almiñana inquired about the grading of the site, stormwater, the lighting, noting preference for warm temperature lights of 3000K or less. He requested the team comply with lighting that was wildlife friendly, which was addressed by Ms. Donnon and Ms. Poindexter (01:59:51). With regards to the One Percent for Art, Ms. Donnon and Ms. Sourbeer noted they didn't need to comply, because there's no city dollars in the project because they're all federal funding. Commissioner McEneaney inquired about bird safe glass and asked if stones from the previous school building could be salvaged for benches. Commissioner Lowe wanted to know how specific properties were obtained for the facility requesting research, with regards to One Percent for Art requirements (02:03:58).

Seeing no further questions or comments from the Commission, Chairperson Roesch asked for a motion to return with more information on stormwater management, lighting, bird safe glass options, screen of the rooftop mechanical equipment, and a determination of the requirements of One Percent for Art (02:11:49).
