

Paths to Legal Status for Survivors of Crime

Options

- Self-Petitions under the Violence Against Women Act (VAWA)
- Removal of Conditions on Green Card based on abuse
- U visa
- T visa
- Other immigration relief related to abuse

Violence Against Women Act (VAWA) Self-Petition

OVERVIEW

- Special visa for immigrants who are abused by certain U.S. citizen and permanent resident spouses and family members
- An immigrant victim can petition for a green card themselves.
 Their abuser does not have to know.

Who Qualifies for a VAWA Self-Petition

WHO QUALIFIES AS A SELF-PETITIONER?

- Abused spouse of a USC or LPR
- Abused child of USC or LPR
- \square Non abused spouse of a USC or LPR whose child is abused by USC or GCH
- Abused parent of a USC son or daughter.

WHO QUALIFIES AS A DERIVATIVE?

Unmarried children under 21 of an abused spouse are automatically included in the application to get status.

***The self-petition may be filed by male victims of abuse; marriage may be hetero- or homosexual.

Benefits of VAWA Self-Petition

BENEFITS

- Self-petitioner and children eligible for:
 - Deferred action: Government won't try to deport
 - Permission to work legally in the U.S.
 - May be able to apply for Green Card right away

What Documents Do You Need For VAWA Self-Petition?

_

IMMIGRANT VICTIM MUST PROVE:

- 1. Legal relationship with USC or green card holder;
- In spousal cases, good faith marriage (not JUST for immigration purposes);
- 3. That they lived with the abuser at some point;
- 4. Battery (physical abuse) or extreme cruelty; AND
- 5. Good moral character

VAWA Battered Spouse Waiver

OVERVIEW

- Available to immigrant survivors of abuse who <u>already</u> have a green card BUT the green card is <u>"conditional"</u> (valid for only two years) because they had been married < 2 years at the time it was approved.
- Can apply to remove conditions and obtain lawful permanent residency without abusers knowledge and participation through a battered spouse waiver.

VAWA Battered Spouse Waiver

• IMMIGRANT VICTIM MUST PROVE:

- 1. Good faith marriage
- 2. Battery (physical abuse) or extreme cruelty

DEADLINES

Can file before, during or after 90-day period before expiration of conditional residency

U Visa

• PURPOSE:

 Created to encourage undocumented immigrants to report crimes and cooperate with law enforcement to help keep our communities safe

U visa

BENEFITS:

- Employment Authorization for Bona Fide applications (while case is pending - Can take around 4-5 years)
- A four-year nonimmigrant status once petition approved with path to legal permanent resident status (10+ year process)
- Some family members can get status too (children <21, spouses, parents and siblings if victim <21)

U visa

REQUIREMENTS:

- 1. That they are a **victim** of a "**qualifying criminal activity**"
- 2. That they have information about the crime
- 3. That they have been **helpful**, are being helpful or are willing to be helpful in investigation and/or prosecution of crime
 - MUST BE certified by law enforcement agency or other agency with investigative authority
- 4. That the crime occurred in the U.S.
- 5. That they have suffered "substantial physical or mental abuse" as a result of the crime

U visa

- WHO IS A VICTIM?
 - Direct Victim
 - Bystander who suffers unusually direct injury
 - Indirect victim
 - Certain family members of the direct victim if they are deceased due to murder or manslaughter or incapacitated

WHICH CRIMES "QUALIFY"?

Abusive Sexual Contact

Domestic Violence

Felonious Assault

Kidnapping

U Visa

WHAT DOES IT MEAN TO BE HELPFUL TO LAW ENFORCEMENT?

- Must cooperate, but an arrest, prosecution, or conviction of the perpetrator is not required
- Victim cannot refuse to provide <u>reasonable</u> requested assistance
- Ongoing responsibility to cooperate
- Certifying official can withdraw

T visa

ELIGIBILITY REQUIREMENTS

- Victim of a Severe Form of Trafficking in Persons, i.e. Sex or Labor Trafficking
- **2. Physically Present** in the U.S. on "Account of" trafficking
- 3. Has Helped With **Any Reasonable Request** for Help in an Investigation or Prosecution of trafficking (if over 18)
 - Law Enforcement Certification not required
- 4. Would Suffer **Extreme Hardship Upon Removal** Involving Unusual and Severe Harm

Benefits of T

Benefits

- Similar to U 4 years of T nonimmigrant status with employment authorization
- Shorter processing times and no visa backlog
- Eligible for "refugee" benefits
- Can apply for green card after 3 years of continuous presence OR once underlying investigation/prosecution completed, whichever is first
 - Advance Parole available for travel during T period.
