Mr. Smith also took a moment to sincerely thank Sarah McEneaney for her service to the Philadelphia Art Commission over the last few years. Sarah was appointed as a Commissioner in July 2021. Appreciation was noted for Sarah's dedication and thoughtful comments for each and every project. 2000 Arch Street

Zoning: Building identification signage within CMX-4 District

Mr. Smith introduced one appeal of the Sign and Streetery Committee recommendations, dating back to the August 30, 2023 meeting. The project is located at 2000 Arch Street. The applicant will have an opportunity to present their project to the full commission. At the Sign and Streetery Committee meeting back in 2023, the Committee recommended denial of four building identification signs. At the time the Committee recommended only two building ID signs and noted they could be placed on any two facades of the applicant's choosing.

Bus Shelter Upgrades Various locations

Review Type: Encroachment in the public right-of-way Project Details: Five new bus shelter installations

Applicant: Office of Transportation and Infrastructure Systems (OTIS)

Mr. Smith presented three Administrative Items to the Commission, beginning with Bus Shelter Upgrades. All three Administrative Items required a consensus vote (00:42:56).

The Office of Transportation and Infrastructure Systems (OTIS), in partnership with Intersection has submitted a new round of bus shelter upgrades as part of their on-going shelter improvement program. The Art Commission typically reviews a series of either new or replacement bus shelter locations several times a year as administrative items. Today's proposal is for five new bus shelters at various locations around the City. All the locations are proposing new shelters where currently no shelter exists. Art Commission staff has reviewed each location in terms of Complete Street standards. While the recommended Complete Street walking zone dimensions cannot be met at one of the 5 locations, staff recommends approval as the shelters offer improved conditions for public transit riders. A representative from OTIS or Intersection is in attendance to answer any questions you may have.

Baxter Water Treatment Plant – Roof replacement 9001 State Road

Review Type: Minor construction on City Property

Project Details: Roof replacement

Applicant: Philadelphia Water Department (PWD)

The Philadelphia Water Department working with Trans-Pacific Engineering Corporation, is seeking administrative approval to demolish and replace the existing roofing systems in kind with new systems to improve and extend the reliability of each building on the water treatment facility campus. The project involves the removal and replacement of roofs on four buildings at the Baxter Water Treatment Plan. Additional work includes new flashing, new roof drains, new in-kind replacement of existing roof mounted HVAC equipment and associated electrical components. A representative from TPEC or PWD is here to help answer any questions you may have. AC staff can also flip through the following slides which are the full CD set for the proposed scope of work.

West Mill Creek Playground – Wall and Basketball Court Reconstruction 5049-5069 Funston Street

Review Type: Minor construction on City Property
Project Details: Wall and Basketball court reconstruction

Applicant: Rebuild

Presenter: KS Engineers

Rebuild working with KS Engineering, is seeking administrative approval for various site improvements at West Mill Creek Playground. The scope of work proposes to remove and replace two sections of a brick retaining wall that have been structurally compromised adjacent to an existing basketball court. The existing foundations of these compromised areas will be evaluated and any additional damaged portions of the wall or fencing above the top of the wall will be replaced in kind. To minimize future damage to the wall several invasive tree species identified by PPR will be removed from the back and top of the wall.

Additionally, Rebuild is proposing to repave and restripe the adjacent basketball court, create an ADA-compatible ramp from the Farson Street elevation to the court and integrate handrails to existing access stairs.

Improvements to the lighting as well as new security cameras, bike racks and seating will also be included. New youth and adult themed games and exercises stations will be
