Project Details: Eight new bus shelter installations

Applicant: Office of Transportation and Infrastructure Systems (OTIS)

The Office of Transportation and Infrastructure Systems (OTIS), in partnership with Intersection, has submitted a series of bus shelter upgrades as part of their on-going shelter improvement program. The Art Commission typically reviews new or replacement bus shelter locations several times a year as administrative items. Today's proposal is for eight new bus shelters at various locations around the City. Art Commission staff have reviewed and recommend for approval.

Commissioner Krakauskas asked what the budget is? John answered that the budget is not set but is less than a million dollars.

Margurite Anglin from Creative Philadelphia clarified that if the budget is less than a million, there is not a requirement for percent for art (00:58:33)
