 Zoning <u>Bill 250334</u>: Amending section 14-1000 of the Philadelphia Code, entitled Historic Preservation, requiring notification to City Council Members of historical designations in the City of Philadelphia. Introduced by Councilmember Bass on April 10, 2025.

Introduced by Councilmember Squilla for Council President Johnson on March 20, 2025.
